AN ACT to amend the public health law, in relation to adding xylazine to the depressants designated as controlled substances

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 1 of section 3305 of the public health law is amended by adding a new paragraph (e) to read as follows:

- (e) to any individual who possesses, sells, administers, prescribes, 4 or distributes any substance containing xylazine expressly intended for administration through injections to cattle or other nonhuman species and that are approved by the federal food and drug administration solely for such use.
  - § 2. Subdivision (e) of schedule I of section 3306 of the public health law is amended by adding a new paragraph 7 to read as follows:
- (7) Xylazine (N- (3, 6-dimethylphenyl) 5, 6-dihydro-4H-1,3 thiazin-10 2-a-mine). This subdivision shall not include any substance containing 11 xylazine expressly intended for administration through injections to 12 13 cattle or other nonhuman species and that are approved by the federal food and drug administration. Any individual who knowingly and willfully 15 administers to themself or another person, prescribes, dispenses or distributes such substances when any such substance is intended for 16 17 human consumption or for any purpose other than injection to cattle or 18 nonhuman species shall be subject to the same penalties as any individ-
