AN ACT to amend the executive law, in relation to establishing the kinship legal network program

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. The executive law is amended by adding a new section 501-i 2 to read as follows:
- § 501-i. Kinship legal network program. 1. There is hereby created within the office of children and family services a kinship legal network program. Such program shall be comprised of not-for-profit legal services organizations and not-for-profit agencies serving kinship caregivers, as defined by subdivision twenty-two of section three hundred seventy-one of the social services law.
- 9 <u>2. The kinship legal network program shall:</u>
- 10 (a) provide legal representation to kinship caregivers in matters
  11 including, but not limited to:
- 12 (i) custody and quardianship;
- 13 (ii) child support;
- 14 (iii) abuse and neglect;
- 15 (iv) adoption;
- 16 (v) eligibility for public benefits, including, but not limited to,
- 17 <u>public assistance and supplemental nutrition assistance program bene-</u>
  18 fits; and
- 19 <u>(vi) foster care certification; and</u>
- 20 <u>(b) establish and coordinate a statewide kinship information and</u> 21 <u>referral network.</u>
- 22 3. (a) The office of children and family services shall provide grants
- 23 of not less than eight million dollars annually to eligible not-for-pro-
- 24 fit legal services organizations and not-for-profit agencies serving
- 25 <u>kinship caregivers to provide kinship legal network services pursuant to</u>
- 26 <u>subdivision two of this section.</u>
- 27 (b) Each not-for-profit legal organization shall be awarded no more 28 than fifteen percent of the funding provided pursuant to paragraph (a)

- (i) data collection;

  - (iii) task force meetings; and
- 7 <u>(iv) technical assistance.</u>
- 8 <u>4. The commissioner of children and family services, on or before</u> 9 <u>October first, two thousand twenty-five, and biannually thereafter,</u>
- 10 shall submit a report to the chair of the senate finance committee and
- 11 the chair of the assembly ways and means committee. Such report shall
- 12 <u>include</u>, but not be limited to:
- 13 (a) a review of the basis for selection of entities participating in the kinship legal network program;
- 15 (b) the administrative method used to carry out the kinship legal 16 network program;
- 17 (c) the number of kinship caregivers assisted through the kinship
- 18 <u>legal network program and whether their legal matter was resolved by</u>
- 19 counsel and advice or representation at an administrative or court
- 20 proceeding, and the outcomes of such proceedings; and
- 21 (d) whether such outcomes were reached by settlement or administrative
- 22 <u>or judicial decision.</u>
- § 2. This act shall take effect immediately.
