AN ACT to amend chapter 20 of the laws of 2009 amending the vehicle and traffic law, the general municipal law and the public officers law relating to owner liability for failure of operator to comply with traffic control indications, in relation to extending the provisions of such chapter

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 24 of chapter 20 of the laws of 2009 amending the vehicle and traffic law, the general municipal law and the public officers law relating to owner liability for failure of operator to comply with traffic control indications, the opening paragraph and subdivision (k) as amended by section 9 of part TT of chapter 58 of the laws of 2019, is amended to read as follows:

§ 24. This act shall take effect on the thirtieth day after it shall have become a law; provided, however, that sections seven, sixteen, and twenty-one through twenty-three of this act shall expire December 1, ~~[2024]~~ 2029 when upon such date the provisions of ~~[this act]~~ such sections shall be deemed repealed; provided that:

(a) ~~[the amendments to section 235 of the vehicle and traffic law made by section one of this act shall be subject to the expiration and reversion of such section pursuant to subdivision (p) of section 406 of chapter 166 of the laws of 1991, as amended, when upon such date the provisions of section two of this act shall take effect;~~

(b) ~~the amendments to section 235 of the vehicle and traffic law made by section two of this act shall be subject to the expiration and reversion of such section pursuant to section 17 of chapter 746 of the laws of 1988, as amended, when upon such date the provisions of section three of this act shall take effect;~~

(c) ~~the amendments made to subdivision 1 of section 236 of the vehicle and traffic law made by section four of this act shall be subject to the expiration and reversion of such subdivision pursuant to section 17 of~~

~~(h) the amendments to paragraph a of subdivision 5-a of section 401 of the vehicle and traffic law made by section fourteen of this act shall be subject to the expiration and reversion of such paragraph pursuant to section 17 of chapter 746 of the laws of 1988, as amended, when upon such date the provisions of section fifteen of this act shall take effect;~~

~~(i)~~ the amendments [made] to the opening paragraph and paragraph (c) of subdivision 1 of section 1809 of the vehicle and traffic law made by section seventeen of this act shall not affect the expiration and reversion of such subdivision and shall be deemed to expire therewith when upon such date the provisions of section eighteen of this act shall take effect; and provided that the amendments made to subdivision 1 of section 1809 of the vehicle and traffic law made by section eighteen of this act shall not affect the expiration of such subdivision and shall be deemed to expire therewith;

~~(j)~~ (b) the amendments [made] to subdivision 1 of section 371 of the general municipal law made by section twenty of this act shall be subject to the expiration and reversion of such section pursuant to section 17 of chapter 746 of the laws of 1988, as amended, when upon such date the provisions of section twenty-one of this act shall take effect; and

~~(k)~~ (c) any such local laws as may be enacted pursuant to this act shall remain in full force and effect only until December 1, [2024] 2029.

§ 2. This act shall take effect immediately.
