AN ACT to amend the executive law and the general business law, in relation to directing the division of homeland security and emergency services to develop rules and regulations relating to truck rental security

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. Subdivision 2 of section 709 of the executive law is 2 amended by adding a new paragraph (w) is added to read as follows:
- 3 (w) Promulgate rules and regulations within twelve months of the 4 effective date of this paragraph, in consultation with the department of 5 transportation and the department of state, to ensure that:
- 6 (i) any person or organization, or any subsidiary or affiliate,
 7 including a franchise, in the business of renting trucks, vans or trail8 ers to the public from locations in this state, be registered with the
 9 division of homeland security and emergency services;
- 10 <u>(ii) each such person or organization maintains accurate records of</u>
 11 <u>any person renting a truck, van or trailer for at least two years; and</u>
- 12 <u>(iii) any person or organization, or any subsidiary or affiliate,</u>
 13 <u>including a franchise, in the business of renting trucks, vans or trail-</u>
- 14 ers to the public require a valid driver's license and at least one
- 15 other form of identification to rent trucks, vans or trailers and
- 16 require that meaningful assurances are made by the rental entity to
- 17 <u>verify the identity of any person renting a truck, van or trailer;</u>
- 18 (iv) any person renting a truck, van or trailer may be checked against
- 19 state or federal criminal databases for the purposes of screening for
- 20 possible terrorists; and
- 21 <u>(v) the division shall develop and promote best practices for the</u> 22 <u>truck rental industry in this state, and work to educate persons and</u>

- § 2. Subdivision 1 of section 396-z of the general business law is amended by adding a new paragraph (m) to read as follows:
- (m) "Truck rental company" means any person or organization, or any subsidiary or affiliate, including a franchisee, in the business of renting trucks, vans or trailers to the public from locations in this state.
- § 3. Subdivision 1 of section 396-z of the general business law is amended by adding a new paragraph (k) to read as follows:
- (k) "Truck rental company" means any person or organization, or any subsidiary or affiliate, including a franchisee, in the business of renting trucks, vans or trailers to the public from locations in this state.
- 15 § 4. Section 396-z of the general business law is amended by adding a 16 new subdivision 13-b to read as follows:
 - 13-b. For truck rental companies, the following disclosure notice shall be made on the face of the rental agreement either by stamp, label or as part of the written contract or on any other written document provided to the authorized driver at the time such driver takes possession of the vehicle, shall be set apart in boldface type and in no smaller print than ten point type:
 - NOTICE: BY ENTERING INTO THIS RENTAL AGREEMENT, YOU UNDERSTAND THAT YOUR NAME AND INFORMATION MAY BE CHECKED AGAINST STATE OR FEDERAL CRIMINAL DATABASES FOR THE PURPOSES OF SCREENING FOR POSSIBLE TERRORISTS.
- § 5. This act shall take effect on the ninetieth day after it shall 26 27 have become a law; provided that the amendment to section 396-z of the 28 general business law made by section two of this act shall not affect the repeal of such section and shall be deemed repealed therewith, when 29 30 upon such date the provisions of section three of this act shall take 31 effect; and provided, further, that the amendment to section 396-z of 32 the general business law made by section four of this act shall survive 33 the repeal and reversion of such section as provided in subdivision (a) 34 of section 4 of chapter 109 of the laws of 2018, as amended; provided further that any rules and regulations necessary to implement the 36 provisions of this act on its effective date are authorized to be 37 promulgated on or before such effective date.
