Introduced by Sens. JACKSON, BAILEY, FELDER, FERNANDEZ, SEPULVEDA -- read twice and ordered printed, and when printed to be committed to the Committee on Elections -- recommitted to the Committee on Elections in accordance with Senate Rule 6, sec. 8 -- reported favorably from said committee, ordered to first and second report, ordered to a third reading, amended and ordered reprinted, retaining its place in the order of third reading

AN ACT to amend the election law, in relation to including a statement on the envelopes of ballots for absentee voters and special presidential voters for signature affirmation

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 6 of section 7-122 of the election law, as  
2 amended by chapter 411 of the laws of 2019, is amended to read as  
3 follows:

4 6. On the reverse side of such inner affirmation envelope shall be  
5 printed the following statement:

### AFFIRMATION

6 I do declare that I am a citizen of the United States, that I am duly  
7 registered in the election district shown on the reverse side of this  
8 envelope and I am qualified to vote in such district; that I will be  
9 unable to appear personally on the day of the election for which this  
10 ballot is voted at the polling place of the election district in which I  
11 am a qualified voter because of the reason given on my application here-  
12 tofore submitted; that I have not qualified nor do I intend to vote  
13 elsewhere, that I have not committed any act nor am I under any imped-  
14 iment which denies me the right to vote.

15 I hereby declare that the foregoing is a true statement to the best of  
16 my knowledge and belief, and I understand that if I make any material  
17 false statement in the foregoing statement of absentee voter, I shall be  
18 guilty of a misdemeanor.

11 § 2. Subdivision 3 of section 7-125 of the election law, as amended by  
 12 chapter 411 of the laws of 2019, is amended to read as follows:

13 3. On the reverse side of such envelope shall be printed the follow-  
 14 ing statement:

15 STATEMENT OF SPECIAL PRESIDENTIAL VOTER

16 I do declare I am a qualified special presidential voter of said  
 17 district; that I am not qualified and am not able to qualify to vote  
 18 elsewhere than as set forth on the reverse side of this envelope; that I  
 19 am a citizen of the United States; that on the date of the election for  
 20 which this ballot is voted, I will be at least eighteen years of age;  
 21 and that I have not committed any act, nor am I under any impediment,  
 22 which denies me the right to vote.

23 I hereby declare that the foregoing is a true statement to the best of  
 24 my knowledge and belief, and I understand that if I make any material  
 25 false statement in the foregoing statement, I shall be guilty of a  
 26 misdemeanor.
