AN ACT to amend the civil service law, in relation to waiving the state application fee for all civil service examinations for all veterans

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraph (b) of subdivision 5 of section 50 of the civil service law, as amended by chapter 490 of the laws of 2019, is amended to read as follows:

3 (b) Notwithstanding the provisions of paragraph (a) of this subdivision, the state civil service department, subject to the approval of the director of the budget, a municipal commission, subject to the approval 7 of the governing board or body of the city or county, as the case may be, or a regional commission or personnel officer, pursuant to governmental agreement, may elect to waive application fees, or to abolish fees for specific classes of positions or types of examinations or 10 candidates, or to establish a uniform schedule of reasonable fees 12 different from those prescribed in paragraph (a) of this subdivision, 13 specifying in such schedule the classes of positions or types of exam-14 inations or candidates to which such fees shall apply; provided, howev-15 er, that fees shall be waived for candidates who certify to the state civil service department, a municipal commission or a regional commission that they are unemployed and primarily responsible for the support 17 18 of a household, or are receiving public assistance. Provided further, the state civil service department shall waive the state application fee 19 20 for <u>all</u> examinations [for original appointment] for all veterans. 21 Notwithstanding any other provision of law, for purposes of this 22 section, the term "veteran" shall mean a person who has served in the 23 armed forces of the United States or the reserves thereof, or in the 24 army national guard, air national guard, New York guard, or the New York 25 naval militia, and who (1) has been honorably discharged or released

from such service under honorable conditions, or (2) has a qualifying condition, as defined in section three hundred fifty of the executive law, and has received a discharge other than bad conduct or dishonorable from such service, or (3) is a discharged LGBT veteran, as defined in section three hundred fifty of the executive law, and has received a discharge other than bad conduct or dishonorable from such service. The term "armed forces" shall mean the army, navy, air force, marine corps, and coast guard.

- § 2. Paragraph (b) of subdivision 5 of section 50 of the civil service law, as amended by section 35 of part PP of chapter 56 of the laws of 2022, is amended to read as follows:
- 12 (b) Notwithstanding the provisions of paragraph (a) of this subdivision, the state civil service department, subject to the approval of the 13 14 director of the budget, a municipal commission, subject to the approval 15 of the governing board or body of the city or county, as the case may be, or a regional commission or personnel officer, pursuant to govern-16 17 mental agreement, may elect to waive application fees, or to abolish 18 fees for specific classes of positions or types of examinations or candidates, or to establish a uniform schedule of reasonable fees 19 different from those prescribed in paragraph (a) of this subdivision, 20 21 specifying in such schedule the classes of positions or types of examinations or candidates to which such fees shall apply; provided, howevthat fees shall be waived for candidates who certify to the state 23 civil service department, a municipal commission or a regional commis-24 sion that they are unemployed and primarily responsible for the support 25 26 of a household, or are receiving public assistance. Provided further, 27 the state civil service department shall waive the state application fee 28 for <u>all</u> examinations [for original appointment] for all veterans. Notwithstanding any other provision of law, for purposes of this 29 section, the term "veteran" shall mean a person who has served in the 30 31 armed forces of the United States or the reserves thereof, or in the 32 army national quard, air national quard, New York quard, or the New York 33 naval militia, and who (1) has been honorably discharged or released 34 from such service under honorable conditions, or (2) has a qualifying 35 condition, as defined in section one of the veterans' services law, and 36 has received a discharge other than bad conduct or dishonorable from 37 such service, or (3) is a discharged LGBT veteran, as defined in section one of the veterans' services law, and has received a discharge other 39 than bad conduct or dishonorable from such service. The term "armed 40 shall mean the army, navy, air force, marine corps, and coast forces" 41 guard.
- § 3. This act shall take effect immediately; provided, however, that section two of this act shall take effect on the same date and in the same manner as section 35 of part PP of chapter 56 of the laws of 2022, takes effect.
