AN ACT to amend the executive law, the general municipal law, and the public authorities law, in relation to providing eligibility for state or local public benefits regardless of immigration status

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The executive law is amended by adding a new section 170-g 2 to read as follows:

§ 170-q. Eligibility for state or local public benefits regardless of 4 immigration status. A state agency may, at its discretion, provide state or local public benefits, as defined by the federal personal responsibility and work opportunity reconciliation act 8 U.S.C. 1621 or any successor provision, to persons who, but for such federal law restricting eligibility for such benefits based on immigration status, would be otherwise eliqible for such benefits from such agency. For the purposes of this section, a "state agency" shall mean any department, bureau, commission, board, division, office, or agency of the state.

12 § 2. The general municipal law is amended by adding a new section 13 99-h-1 to read as follows:

§ 99-h-1. Eligibility for state or local benefits regardless of immi-15 gration status. A municipal corporation may, at its discretion, provide state or local public benefits, as defined by the federal personal responsibility and work opportunity reconciliation act 8 U.S.C. 1621 or any successor provision, to persons who, but for such federal law restricting eligibility for such benefits based on immigration status, 20 would be otherwise eligible for such benefits from such municipal corpo-21 ration. For purposes of this section, a "municipal corporation" shall mean a county, city, town, village, school district, or board of cooperative educational services of this state or a board of higher education 24 in a city having a population of one million or more.
