AN ACT to amend the mental hygiene law, in relation to establishing the rural suicide prevention council; and providing for the repeal of such provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The mental hygiene law is amended by adding a new section 7.49 to read as follows:

§ 7.49 Rural suicide prevention council.

(a) There shall be established by the office, a council on rural suicide prevention. Members of the council shall include the commissioner or his or her designee, the commissioner of health or his or her designee, and the commissioner of agriculture and markets or his or her designee. There shall be twelve additional members of the council including four members appointed by the governor; three members shall be appointed by the speaker of the assembly; three members shall be appointed by the temporary president of the senate; one member shall be appointed by the minority leader of the assembly; and one member shall be appointed by the minority leader of the senate.

(b) The commissioner shall designate the chair from appointed council members. Vacancies in the membership of such council shall be filled by the appropriate appointing authority.

(c) The membership of the council may include, but not be limited to, representatives of the state conference of local mental hygiene directors; mental health professionals and practitioners with experience in the delivery of mental health treatment or suicide prevention services

11 (d) Duties of the council shall include, but not be limited to:

12 (1) identifying barriers to mental health and substance use treatment
13 and prevention services, as well as the causes and conditions related to
14 death by suicide or suicide attempts in rural parts of the state;

15 (2) determine if there is sufficient capacity for peer supports and
16 mental health crisis services;

17 (3) assess the use of the 988 suicide and crisis lifeline in rural
18 areas of the state and identify strategies to increase utilization;

19 (4) identifying vulnerable populations in rural areas and the preva-
20 lence of suicide among such populations including, but not limited to,
21 farmers and agricultural workers;

22 (5) identifying policies, practices, resources, services, and poten-
23 tial legislation that aim to reduce death by suicide and suicide
24 attempts and acknowledge the demographic and cultural differences in
25 rural communities;

26 (6) offering recommendations on policies and procedures to improve the
27 coordination of services and resources among agencies involved in the
28 delivery of mental health, substance use, or suicide prevention
29 services; and

30 (7) making recommendations on funding initiatives to increase access
31 to mental health, substance use, and suicide prevention services in
32 rural areas and facilitate the use of innovative intervention strategies
33 specific to individuals residing in rural areas.

34 (e) The rural suicide prevention council shall meet not less than
35 three times annually, or as deemed necessary by the chair of the council
36 or the commissioner.

37 (f) The members of the rural suicide prevention council shall receive
38 no compensation for their services but shall be allowed their actual and
39 necessary expenses incurred in the performance of their duties.

40 The council shall provide a preliminary report to the governor and the
41 legislature of its findings, conclusions, recommendations and activities
42 already undertaken by the council, not later than nine months after the
43 effective date of this act, and a final report of its findings, conclu-
44 sions, recommendations and activities already undertaken by the council,
45 not later than eighteen months after the effective date of this section
46 and shall submit with its reports legislative proposals as it deems
47 necessary to implement its recommendations.

48 § 2. This act shall take effect on the sixtieth day after it shall
49 have become a law and shall expire 2 years after such effective date
50 when upon such date the provisions of this act shall be deemed repealed.
