AN ACT to amend the tax law, in relation to providing a tax credit for certain taxpayers who suffer the birth of a stillborn child

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Section 606 of the tax law is amended by adding a new 2 subsection (ooo) to read as follows:

(000) Stillbirth tax credit. (1) A taxpayer shall be allowed a refund-4 able credit against the tax imposed by this article equal to two thousand dollars for the birth of a stillborn child, provided the stillborn child would have been a dependent of the taxpayer as defined by section 152 of the Internal Revenue Code. The credit shall be allowed for the taxable year in which a certificate of stillbirth is issued pursuant to section four thousand one hundred sixty-a of the public health law.

- (2) For purposes of this subsection, "birth of a stillborn child" 10 shall mean the birth of a child for whom a certificate of stillbirth has 11 12 been issued pursuant to section four thousand one hundred sixty-a of the 13 public health law.
- 14 § 2. This act shall take effect immediately and shall apply to taxable 15 years commencing on and after January 1, 2024. Effective immediately, 16 the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its effective date are
- authorized to be made and completed on or before such date.
