AN ACT to amend the correction law, in relation to custody and visitation rights of certain sex offenders

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 168-w of the correction law, as renumbered by chapter 604 of the laws of 2005, is renumbered section 168-x and a new section 168-w is added to read as follows:

2 § 168-w. Custody and visitation rights. 1. Any sex offender designated
3 as a sexual predator, or a sexually violent offender, or classified as a
4 level two or three risk, for a crime involving a child shall be, except
5 in extraordinary circumstances, prohibited from being granted by a court
6 physical or legal custody of, or unsupervised visitation with, a child.

7 2. Any sex offender classified as a level two or three risk shall be
8 presumed to be ineligible to be granted physical or legal custody of, or
9 unsupervised visitation with, a child, and a court shall grant physical
10 or legal custody of, or unsupervised visitation with, a child only if
11 the sex offender has provided clear and convincing evidence that grant-
12 ing such custody or visitation will be in the best interest of the
13 child.

14 § 2. This act shall take effect on the first of November next succeeding the date on which it shall have become a law.
