AN ACT to amend the environmental conservation law, in relation to big game hunting authorization for the county of Onondaga; and providing for the repeal of such provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law is amended by adding a new item (p) to read as follows:

<u>Onondaga</u>	<u>Saturday after November</u>	<u>crossbow, muzzle</u>
	<u>15 through first Sunday</u>	<u>loading firearm,</u>

§ 2. Item (f) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law, as amended by section 2 of chapter 152 of the laws of 2020, is amended to read as follows:

§ 3. Paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law is amended by adding a new item (n) to read as follows:

§ 4. Item (f) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law, as amended by section 4 of chapter 152 of the laws of 2020, is amended to read as follows:

§ 5. This act shall take effect immediately; provided, however, that:

a. the amendments to paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section one of this act shall be subject to the expiration and reversion of such paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as amended;

b. the amendments to item (f) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law made by section two of this act shall be subject to the expiration and reversion of such item pursuant to paragraph d of section 5 of chapter 152 of the laws of 2020, as amended by section five of this act;

c. sections three and four of this act shall take effect upon the expiration and reversion of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law, as provided in section 13 of chapter 600 of the laws of 1993, as amended; and

d. nothing contained in this act shall be construed so as to extend the provisions of this act beyond October 1, 2025, when upon such date this act shall expire and the provisions contained herein shall be deemed repealed.
