AN ACT to amend the social services law, in relation to allowing for child protective services workers to complete certain required training through distance learning methods

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph (b) of subdivision 5 of section 421 of the social
2 services law, as amended by chapter 525 of the laws of 2006, is amended
3 to read as follows:

4 (b) promulgate regulations setting forth training requirements which
5 shall specify, among other things, that all persons hired by a child
6 protective service on or after April first, nineteen hundred eighty-six
7 shall have satisfactorily completed a course approved by the department
8 within the first three months of employment, in the fundamentals of
9 child protection, provided, however, that on or after April first, two
10 thousand twenty-four, such course may be satisfactorily completed
11 through distance learning methods which evince that all participants are
12 in attendance for the duration of the course and are able to ask ques-
13 tions of the instructor, excluding the annual in service training
14 requirement. Such course shall include at least basic training in the
15 principles and techniques of investigations, including relationships
16 with other investigative bodies, legal issues in child protection, and
17 methods of remediation, diagnosis, treatment and prevention. Such regu-
18 lations shall also specify that all persons employed by a child protec-
19 tive service on or after December first, two thousand six shall satis-
20 factorily complete six hours of annual in service training, beginning in
21 their second year of employment. Such annual in service training shall
22 include, but is not limited to, review of the protocols for identifica-
23 tion and investigation of child abuse and maltreatment, any developments
24 in legal, treatment and prevention issues in child protection, and

3 § 2. Subdivision 1 of section 423 of the social services law is
4 amended by adding a new paragraph (f) to read as follows:

5 (f) every local department of social services may prepare and submit
6 to the commissioner, including the determination mentioned herein, a
7 request to fulfill the training requirements, as specified by paragraph
8 (b) of subdivision five of section four hundred twenty-one of this
9 title, through distance learning methods, upon a determination by a
10 local department of social services that the use of such distance learn-
11 ing methods shall be beneficial to the performance of those functions
12 assigned by this title to the child protective service, provided, howev-
13 er, that such distance learning methods shall not be used for the annual
14 in service training requirement.

15 § 3. This act shall take effect immediately.
