AN ACT to amend the penal law, in relation to bias-related graffiti

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 3 of section 485.05 of the penal law, as amended by section 3 of part R of chapter 55 of the laws of 2020, is amended to read as follows:

§ 2. This act shall take effect on the first of November next succeeding the date on which it shall have become a law.
