Introduced by Sens. RIVERA, MAY, WEBB -- read twice and ordered printed, and when printed to be committed to the Committee on Health -- committee discharged, bill amended, ordered reprinted as amended and recommitted to said committee -- reported favorably from said committee, ordered to first and second report, ordered to a third reading, amended and ordered reprinted, retaining its place in the order of third reading

AN ACT to amend the public health law, in relation to establishing a community-based paramedicine demonstration program; and providing for the repeal of such provisions upon expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. The public health law is amended by adding a new section 3018 to read as follows:

§ 3018. Community-based paramedicine demonstration program. 1. The department shall establish a community paramedicine demonstration program to evaluate the role of emergency medical services personnel in the delivery of health care services in the community in non-emergent settings.

2. For purposes of this section, "emergency medical services personnel" shall mean an emergency medical technician, or an advanced emergency medical technician as defined in this article.

3. This program shall authorize mobile integrated and community paramedicine programs presently operating and approved by the department as of May eleventh, two thousand twenty-three, under the authority of Executive Order Number 4 of two thousand twenty-one, entitled "Declaring a Statewide Disaster Emergency Due to Healthcare staffing shortages in the State of New York" to continue in the same manner and capacity as currently approved for a period of two years following the effective date of this section.

4. Such program shall include but not be limited to:

1 (a) authorizing emergency medical services personnel to provide  
2 services within their scope of practice beyond settings currently

4 (b) authorizing emergency medical service personnel to provide commu-  
5 nity paramedicine, use alternative destinations, telemedicine to facili-  
6 tate treatment of persons in place, and such other services as may be  
7 approved by the commissioner.

8 (c) authorizing emergency medical services personnel providing commu-  
9 nity paramedicine services, with prior approval of the department, to  
10 administer vaccinations against influenza and COVID-19 pursuant to non-  
11 patient specific orders and under the medical direction of a licensed  
12 physician.

13 (d) nothing in this section shall be deemed to allow a person to  
14 provide any service for which a license, registration, certification or  
15 other authorization under title eight of the education law is required  
16 and which the person does not possess, provided that any service being  
17 excluded pursuant to this paragraph shall not include a service that is  
18 within the scope of practice for the respective emergency medical  
19 services personnel.

20 5. Upon the effective date of this section, the department shall  
21 convene a stakeholder advisory panel including patient representatives,  
22 health care facilities operating or utilizing community paramedicine  
23 programs, emergency medical services providers and labor organizations  
24 representing emergency medical services personnel, and labor organiza-  
25 tions representing nursing and other healthcare professional titles  
26 affected by the demonstration program flexibilities to advise the  
27 department to make recommendations on regulations and guidance that  
28 will:

29 (a) evaluate patient safety and standards of care for community param-  
30 edicine programs participating in the demonstration program;

31 (b) establish criteria setting forth permitted tasks that can be  
32 performed by each category of emergency medical services personnel;

33 (c) establish minimum training and competencies required for emergency  
34 medical services personnel to provide patient care services; and

35 (d) work with the department to issue such regulations and guidelines  
36 within ninety days following the assembly of the advisory panel.

37 6. The department shall submit a report on the demonstration program  
38 on an annual basis to the speaker of the assembly, the temporary presi-  
39 dent of the senate, the chairs of the assembly and senate health commit-  
40 tees, and the governor.

41 § 2. This act shall take effect immediately and shall expire and be  
42 deemed repealed 2 years after such date; provided, however, that if this  
43 act shall have become a law on or after May 22, 2023 this act shall take  
44 effect immediately and shall be deemed to have been in full force and  
45 effect on and after May 22, 2023.
