MAYER -- read twice and ordered printed, and when printed to be committed to the Committee on Education -- reported favorably from said committee, ordered to first and second report, amended on second report, ordered to a third reading, and to be reprinted as amended, retaining its place in the order of third reading
- AN ACT to amend the education law, in relation to requiring the dissemination of materials regarding child access prevention and the safe storage of firearms

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The education law is amended by adding a new section 808-a 2 to read as follows: 3 § 808-a. Firearms; child access prevention and safe storage. 1. For 4 the purposes of this section the following terms shall have the follow-5 <u>ing meanings:</u> a. "school district" shall mean any city school district, common 6 7 school district, union free school district, central school district or 8 <u>central high school district;</u> 9 b. "school" shall mean any public school district, charter school, 10 private school, parochial school, or board of cooperative educational 11 services; c. "private school" shall mean a person, firm, association, partner-12 13 ship, or corporation offering or conducting private school instruction 14 in the state; 15 d. "notice" shall mean written information of the model content 16 <u>outlined in subdivision two of this section, produced in a concise</u>, publishable format, such as a brochure, flyer, handbill, leaflet, 17 18 letter, or pamphlet, that is intended to be provided directly to 19 parents, guardians, or persons in parental relation to a student of the 20 school, delivered to a receptacle designated for a student, mailed to a EXPLANATION--Matter in italics (underscored) is new; matter in brackets

4	e. "school year" shall mean the period commencing on the first day of
5	regular instruction and shall end on the last day of instruction.
6	2. a. On or before July first, two thousand twenty-four, the depart-
7	ment shall develop model content for notice, produced in the English
8	language and in common non-English languages spoken in the state, which
9	shall include, at a minimum, information outlining New York's child
10	access prevention laws and laws relating to the safe storage of
11	firearms, including, but not limited to, sections 265.45 and 265.50 of
12	the penal law. The model content shall also include relevant statewide
13	resources and information related to child access prevention, the safe
14	storage of firearms, and firearm violence prevention.
15	b. Such model content shall designate a section for county- and
16	local-specific laws and regulations submitted to it by each county as
17	outlined in subdivision three of this section. The department shall
18	tailor the model content for each county by including in the designated
19	section for county- and local-specific laws and regulations the county-
20	and local-specific laws submitted to it by each county.
21	c. On or before July first, two thousand twenty-five, and each July
22	first thereafter, the department shall update, as necessary, the model
23	content developed pursuant to paragraphs a and b of this subdivision.
24	d. The department shall publish the model content developed and
25	updated pursuant to paragraphs a, b, and c of this subdivision on its
26	website.
27	3. a. On or before May first, two thousand twenty-four, every county
28	shall submit to the department all information of county- and local-spe-
29	cific laws and regulations related to child access prevention and the
30	safe storage of firearms.
31	b. On or before May first, two thousand twenty-five, and each May
32	first thereafter, every county shall submit to the department any
33	updated information, insofar as it exists, of county- and local-specific
34	laws related to child access prevention and the safe storage of
35	firearms.
36	4. Beginning on July first, two thousand twenty-four, all school
37	districts shall provide notice, at the beginning of the first semester
38	or quarter of the regular school year, of the model content outlined in
39	paragraphs a and b of subdivision two of this section; provided, howev-
40	er, that if a child enrolls after the beginning of the school year,
41	notice of the model content shall be provided within one week of such
42	enrollment. Notice of the model content may be provided as a single
43	notice for multiple students living in the same household.
44	5. Beginning on July first, two thousand twenty-four, all school
45	districts shall maintain, through their website or affiliated social
46	media presences, the model content outlined in paragraphs a and b of
47	subdivision two of this section. The model content shall be updated, as
48	necessary, pursuant to paragraph c of subdivision two of this section.
40 49	<u>6. Local schools, school districts, and the department are immune from</u>
49 50	civil liability for any damages allegedly caused by, arising out of, or
50	relating to notice if the entity provided notice using the model content
