AN ACT to amend chapter 192 of the laws of 2011, relating to authorizing certain health care professionals licensed to practice in other jurisdictions to practice in this state in connection with an event sanctioned by New York Road Runners, in relation to extending the provisions thereof

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Chapter 192 of the laws of 2011, relating to authorizing certain health care professionals licensed to practice in other jurisdictions to practice in this state in connection with an event sanctioned by New York Road Runners, as amended by chapter 282 of the laws of 2022, is amended to read as follows:

5 Section 1. Notwithstanding any inconsistent provision of law, any 7 person who is licensed to practice as a physician, physician's assistant, massage therapist, physical therapist, chiropractor, dentist, opto-9 metrist, nurse, nurse practitioner, certified athletic trainer or podia-10 trist in another state or territory, who is in good standing in such 11 state or territory and who has been appointed by the New York Road 12 Runners to provide professional services at an event in this state sanctioned by the New York Road Runners, may provide such professional services to athletes and team personnel registered to train at a 14 location in this state or registered to compete in an event conducted 15 under the sanction of the New York Road Runners in the state without 17 first being licensed pursuant to the provisions of title 8 of the education law. Such services shall be provided only four days before through 19 one day after each of the following events:

a. the New York city marathon scheduled to be held on November [67] 21 **2022**] **5, 2023**;

- b. the Brooklyn half marathon scheduled to be held on May [<del>21, 2022</del>] and a date in May [ 20, 2023;
  - c. the Bronx 10 mile scheduled to be held on September [18, 2022] 17, 2023;
- d. the New York city half marathon scheduled to be held on a date in March 2023;
- e. the Staten Island half marathon scheduled to be held on October  $[9_7 2022]$  8, 2023; and
  - f. the Queens 10k scheduled to be held on June  $[\frac{18}{7}, \frac{2022}{2}]$   $\frac{17}{7}$ ,  $\frac{2023}{2}$ .
- 10 § 2. This act shall take effect immediately and shall expire and be 11 deemed repealed [ $\frac{\text{June 2}}{\text{2}}$ ] <u>December 31</u>, 2023.
- § 2. This act shall take effect immediately and shall be deemed to have been in full force and effect on and after January 1, 2023; provided that the amendments to section 1 of chapter 192 of the laws of 2011, made by section one of this act, shall not affect the repeal of such section and shall be deemed repealed therewith.
