AN ACT to amend the insurance law and the social services law, in relation to capping cost sharing for oral antiviral COVID-19 therapeutics

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- Section 1. Subsection (i) of section 3216 of the insurance law is amended by adding a new paragraph 39 to read as follows:
- 3 (39) (A) Every policy that provides coverage for prescription drugs 4 shall provide coverage for oral antiviral therapeutics approved by the 5 food and drug administration for the treatment of COVID-19.
- 6 (B) The coverage required pursuant to subparagraph (A) of this para-7 graph shall not be subject to annual deductibles or coinsurance.
- 8 § 2. Subsection (k) of section 3221 of the insurance law is amended by 9 adding a new paragraph 23 to read as follows:
- 10 (23) (A) Every policy that provides coverage for prescription drugs 11 shall provide coverage for oral antiviral therapeutics approved by the 12 food and drug administration for the treatment of COVID-19.
- 13 (B) The coverage required pursuant to subparagraph (A) of this para-14 graph shall not be subject to annual deductibles or coinsurance.
- 15 § 3. Section 4303 of the insurance law is amended by adding a new 16 subsection (vv) to read as follows:
- 17 <u>(vv) (1) Every contract issued by a medical expense indemnity corpo-</u>
 18 <u>ration</u>, <u>a hospital service corporation or a health service corporation</u>
- 19 for delivery in this state that provides medical, major medical or simi-
- 20 lar comprehensive-type coverage and provides coverage for prescription
- 21 <u>drugs shall provide coverage for prescribed oral antiviral therapeutics</u>
 22 approved by the food and drug administration for the treatment of
- 22 <u>approved by the food and drug administration for the treatment of</u> 23 <u>COVID-19.</u>
- 24 (2) Such coverage required pursuant to paragraph one of this subsection shall not be subject to annual deductibles or coinsurance.
- § 4. Subdivision 2 of section 365-a of the social services law is amended by adding a new paragraph (nn) to read as follows:

1 (nn) prescribed oral antiviral therapeutics approved by the food and drug administration for the treatment of COVID-19. Coverage required pursuant to this paragraph shall be provided at no cost to the insured.

§ 5. This act shall take effect immediately and shall apply to any policy or contract issued, renewed, modified, altered, or amended on or after January 1, 2025.
