AN ACT to amend the alcoholic beverage control law, in relation to exempting certain parcels of land from licensing restrictions for manufacturers and wholesalers of alcoholic beverages who sell at retail for on-premises consumption

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subparagraph (xiv) of paragraph (a) of subdivision 1 of 2 section 101 of the alcoholic beverage control law, as added by chapter 3 328 of the laws of 2022, is renumbered (xviii) and amended to read as
