AN ACT to amend the environmental conservation law, in relation to establishing the "sporting range good neighbor act"

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. This act shall be known and may be cited as the "sporting
2 range good neighbor act".
- 3 § 2. The environmental conservation law is amended by adding two new
4 sections 37-0123 and 37-0125 to read as follows:
- 5 § 37-0123. Shooting ranges; skeet fields; prevention of lead migration.
6 1. (a) Every skeet field tract at a shooting range shall be a minimum
7 of six hundred yards by three hundred yards with the shooting semicircle
8 located in the middle of the long side.
9 (b) Any shooting range which is unable to comply with the requirements
10 of paragraph (a) of this subdivision shall construct and maintain appro-
11 priate backstops to prevent lead migration outside of the designated
12 skeet field tract. Such backstops shall be constructed of material that
13 effectively captures bullets and shall be covered by a roof to prevent
14 precipitation from eroding such backstops.
- 15 2. No portion of a skeet field tract shall include a wetland or open
16 water source.
- 17 3. As used in this section, the following terms shall have the follow-
18 ing meanings:
- 19 (a) "shooting range" shall mean an outdoor range equipped with targets
20 for use with firearms and shall include, but not be limited to, all
21 rifle, pistol and shotgun ranges.
- 22 (b) "skeet field tract" shall mean a portion of an outdoor shooting
23 range used for clay, sporting clay, trap or skeet shooting.
- 24 § 37-0125. Outdoor shooting range environmental stewardship and lead
25 ammunition material reclamation.

1 1. The department shall promulgate rules and regulations regarding
2 environmental stewardship and lead ammunition material reclamation at
3 outdoor shooting ranges and require reporting by outdoor shooting ranges
4 regarding such ranges' environmental stewardship and lead ammunition
5 material reclamation. Such reporting shall include:

6 (a) Environmental actions that have been completed on the outdoor
7 shooting range;

8 (b) The present environmental setting, including upgrades, if applica-
9 ble, along with previous range maintenance activities;

10 (c) Identification of issues of potential environmental concern asso-
11 ciated with shooting and related lead constituents;

12 (d) Identification, evaluation and prioritization of appropriate
13 actions to manage issues identified pursuant to subdivision three of
14 this section;

15 (e) Identification of short- and long-term action items and steps
16 needed for implementation;

17 (f) An implementation plan for such action items;

18 (g) Identification of ways to measure and document results of lead
19 ammunition material management actions; and

20 (h) Periodic evaluation of progress toward environmental stewardship
21 goals and appropriate revisions of plans.

22 2. As used in this section, the following terms shall have the follow-
23 ing meanings:

24 (a) "shooting range" shall mean an outdoor range equipped with targets
25 for use with firearms and shall include, but not be limited to, all
26 rifle, pistol and shotgun ranges.

27 (b) "skeet field tract" shall mean a portion of an outdoor shooting
28 range used for clay, sporting clay, trap or skeet shooting.

29 § 3. This act shall take effect on the one hundred eightieth day after
30 it shall have become a law.
