AN ACT to amend the public authorities law, in relation to installation and maintenance of automated external defibrillators on trains operated by the metropolitan transportation authority

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 1266-a of the public authorities law, as added by
2 chapter 928 of the laws of 1977, is amended to read as follows:

3 § 1266-a. Medical emergency services. The authority is hereby author-
4 ized and directed to prepare and develop a medical emergency services
5 program to be implemented at a time to be specified in such program for
6 the benefit of persons utilizing transportation and other related
7 services of the authority. Such program [~~may~~] shall include but not be
8 limited to provision for the following: The training of designated
9 employees in first aid, emergency techniques and procedures, handling
10 and positioning of stricken commuters, [~~and~~] knowledge of procedures and
11 equipment used for respiratory and cardiac emergencies, and the
12 provision and availability of at least one automated external defibril-
13 lator, as defined in section three thousand-b of the public health law,
14 on each train operated by the authority in a manner that is in accord-
15 ance with the requirements and protections of such section three thou-
16 sand-b. Such program shall be submitted to the legislature not later
17 than one hundred eighty days next succeeding the effective date of this
18 section.

19 § 2. Paragraph a of subdivision 1 of section 1266-b of the public
20 authorities law, as amended by chapter 396 of the laws of 2005, is
21 amended to read as follows:

22 a. The authority in consultation with the Long Island Rail Road is
23 hereby authorized and directed to implement a comprehensive medical
24 emergency services program, including an emergency response protocol,
25 not later than September first, two thousand five, for the benefit of
26 persons utilizing transportation and other related services of the Long

1 Island Rail Road. Such program shall include but not be limited to
2 provision for the following: The training of designated employees in
3 first aid, emergency techniques and procedures, handling and positioning
4 of stricken commuters, knowledge of procedures and equipment used for
5 respiratory and cardiac emergencies, as well as the provision and avail-
6 ability of at least one automated external defibrillator, as defined in
7 section three thousand-b of the public health law, on each train oper-
8 ated by the Long Island Rail Road in a manner that is in accordance with
9 the requirements and protections of such section three thousand-b, and
10 an emergency response protocol for all employees.
11 § 3. This act shall take effect one year after it shall have become a
12 law.
