AN ACT to amend the education law, in relation to complaints concerning the moral character of individuals who hold or who are applicants for New York State teaching certificates

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The education law is amended by adding a new section 305-a
2 to read as follows:

3 § 305-a. Complaints concerning the moral character of individuals who
4 hold or who are applicants for New York state teaching certificates. 1.
5 The commissioner shall maintain an internal registry of certain active
6 investigations against certified individuals pursuant to part eighty-
7 three of title eight of the New York codes, rules and regulations. The
8 registry shall exclusively include active investigations for which the
9 complaint against a certified individual is a boundary violation between
10 the certificate holder and a student, including but not limited to a
11 sex-related offense or a complaint that is sexual in nature. Such
12 registry shall include information about such certified individuals,
13 including their full name, position or most recent position held, place
14 of employment or place of most recent employment, the date on which the
15 department received the part eighty-three complaint from the school
16 district, the nature of the complaint, the current status of the inves-
17 tigation, and the date by which the department must issue notice
18 whether a substantial question exists as to the moral character of an
19 individual.

20 2. (a) The department shall add an individual to the registry only
21 when the complaint regarding moral character has been made by a super-
22 intendent or chief school administrator if the title of superintendent
23 is not applicable. The department shall add an individual to the inter-
24 nal registry on the same day it assigns the complaint to an investi-
25 gator. The department shall not add an individual to the internal regis-
26 try if the department determines they do not have the authority to

1 investigate that complaint. The department shall ensure that the infor-
2 mation in the registry is regularly updated and accurate.

3 (b) The department shall remove a certified individual from the inter-
4 nal registry on the same day the investigation into the allegation is
5 closed or upon a determination by a hearing officer or the commissioner
6 that the individual has good moral character. The commissioner shall
7 have the authority to determine whether an individual may remain on the
8 registry if the department determines a substantial question exists as
9 to the moral character of the individual. If an individual is added to
10 the list, formal disciplinary proceedings must be promptly instituted,
11 prosecuted, and/or completed.

12 (c) The department shall notify, in writing, an individual on the same
13 day that the individual is added to and removed from the internal regis-
14 try. Within the notice of an individual added to the internal registry,
15 the department shall include the date by which the department must issue
16 notice whether a substantial question exists as to the moral character
17 of an individual. The department shall also include notice of the
18 opportunity for the individual to appeal and instructions on how to do
19 so.

20 3. (a) Upon receiving the request for a background check for an indi-
21 vidual from a school district, the department shall include, with the
22 background check materials, notification if the individual is on the
23 internal registry and shall notify solely the superintendent, or chief
24 school administrator if the title of superintendent is not applicable,
25 of such school district where the individual is seeking employment, that
26 the individual is on the internal registry. Disclosure of the status of
27 an investigation by anyone but the superintendent or chief school admin-
28 istrator shall be prohibited.

29 (b) If the individual is on the internal registry, the department
30 shall provide, along with the background check materials, the individ-
31 ual's full name, position or most recent position held, place of employ-
32 ment or place of most recent employment, the date on which the depart-
33 ment received the part eighty-three complaint, information about the
34 nature of the complaint against the individual, and the date by which
35 the department must issue notice whether a substantial question exists
36 as to the moral character of an individual. The department shall also
37 include the current status of the investigation and make it clear that
38 the outcome of the investigation regarding the individual's moral char-
39 acter has not yet been determined.

40 4. The commissioner shall establish procedures for appeals. Within
41 thirty days from the date an individual receives notice of their inclu-
42 sion in the registry, the individual may commence an appeal to the
43 commissioner. The commissioner shall conduct a review of the appeal,
44 including any supporting documentation provided by the certified indi-
45 vidual. The commissioner shall render a decision on the appeal within
46 thirty days of receiving such appeal.

47 5. Except as provided in this section, information related to part
48 eighty-three investigations shall be confidential and shall not be
49 subject to public disclosure.

50 6. All actions regarding complaints against a certified individual's
51 moral character are pending the prompt institution, prosecution, and
52 completion of formal disciplinary proceedings.

53 § 2. This act shall take effect on the ninetieth day after it shall
54 have become a law.
