AN ACT to amend the environmental conservation law, in relation to prohibiting the sale and distribution of anti-fogging sprays and wipes containing perfluoroalkyl and polyfluoroalkyl substances

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

| 41 | 2. No person shall be held in violation of this title if such person |

| 43 | distributor, such person relied in good faith on the written assurance |
| 44 | of the manufacturer or distributor of such product that such product met |
| 45 | the requirements of this title. Such written assurance shall take such |
| 46 | form as shall be prescribed by the department by regulation. |
| 47 | § 2. Severability. If any clause, sentence, paragraph, subdivision or |
| 48 | section of this act shall be adjudged by any court of competent juris- |
| 49 | diction to be invalid, such judgment shall not affect, impair, or inval- |
| 50 | idate the remainder thereof, but shall be confined in its operation to |
| 51 | the clause, sentence, paragraph, subdivision, section or part thereof |
| 52 | directly involved in the controversy in which such judgment shall have |
| 53 | been rendered. It is hereby declared to be the intent of the legislature |
| 54 | that this act would have been enacted even if such invalid provisions |
| 55 | had not been included herein. |

1 § 3. This act shall take effect December 31, 2023. Effective imme-2 diately, the addition, amendment and/or repeal of any rule or regulation 3 necessary for the implementation of this act on its effective date are 4 authorized and directed to be made and completed on or before such 5 effective date.
