AN ACT to amend the civil service law, in relation to providing additional credits to Nassau county law enforcement explorers

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Short title. This act shall be known and may be cited as
2 the "Nassau future protectors act".

3 § 2. The civil service law is amended by adding a new section 85-e to
4 read as follows:

5 § 85-e. Additional credit allowed for Nassau county law enforcement
6 explorers in competitive examinations; preference in retention upon
7 abolition of positions. 1. Additional credits shall be allowed for
8 participants of the Nassau county law enforcement exploring program in
9 competitive examinations for original appointment. The Nassau county law
10 enforcement exploring program shall be defined as a youth police train-
11 ing program which provides youths between the ages of fourteen and twen-
12 ty with training and on the purpose, mission and objectives of the
13 Nassau county police department, public safety and law enforcement.

14 (a) On all eligible lists resulting from competitive examinations, the
15 names of eligible persons shall be entered in the order of respective
16 final earned ratings on examinations, with the name of the eligible
17 person with the highest final earned ratings at the head of such list,
18 provided, however, that for the purpose of determining final earned
19 ratings, Nassau county law enforcement explorers shall be entitled to
20 receive additional points in a competitive examination for original
21 appointment in Nassau county. An eligible person who served as a Nassau
22 county law enforcement explorer for a minimum of four years shall
23 receive an additional five points. An eligible person who served as a
24 Nassau county law enforcement explorer for less than four years shall
25 receive an additional two points.

1 (b) Such additional credit shall be added to the final earned rating
2 of such Nassau county law enforcement explorer, after such explorer
3 qualified in the competitive examination and shall be granted only at
4 the time of establishment of the resulting eligible list.

5 2. Any candidate, believing themselves to be entitled to additional
6 credit in a competitive examination as provided in this section, may
7 make application for such additional credit at any time between the date
8 of application for examination and the date of the establishment of the
9 resulting eligible list. Such candidates shall be allowed a period of
10 not less than two months from the date of the filing of the application
11 for examination in which to establish by appropriate documentary proof
12 the eligibility to receive additional credit under this section. At any
13 time after two months have elapsed since the final date for filing
14 applications for a competitive examination for original appointment, the
15 eligible list resulting from such examination may be established,
16 notwithstanding the fact that a Nassau county law enforcement explorer
17 who has applied for additional credit has failed to establish the eligi-
18 bility to receive such additional credit. A candidate who fails to
19 establish, by appropriate documentary proof, the eligibility to receive
20 additional credit by the time an eligible list is established shall not
21 thereafter be granted additional credit on such eligible list.

22 3. (a) Except as otherwise provided in this subdivision, no person who
23 has received a permanent original appointment in the civil service of
24 Nassau county thereof from an eligible list on which such person was
25 allowed the additional credit granted by this section as a Nassau county
26 law enforcement explorer, shall thereafter be entitled to any additional
27 credit under this section.

28 (b) Where, at the time of establishment of an eligible list, the posi-
29 tion of a Nassau county law enforcement explorer on such list has not
30 been affected by the addition of credits granted under this section, the
31 appointment of such Nassau county law enforcement explorer from such
32 eligible list shall not be deemed to have been made from an eligible
33 list on which they were allowed the additional credit granted by this
34 section.

35 (c) If, at the time of appointment from an eligible list, a Nassau
36 county law enforcement explorer is in the same relative standing among
37 the eligible persons who are willing to accept appointment as if such
38 explorer had not been granted the additional credits as provided by this
39 section, the appointment from such eligible persons shall not be deemed
40 to have been made from an eligible list on which they were allowed such
41 additional credits.

42 (d) Where a Nassau county law enforcement explorer has been originally
43 appointed from an eligible list on which such explorer was allowed such
44 additional credit, but such appointment is thereafter terminated either
45 at the end of the probationary term or by resignation at or before the
46 end of the probationary term, such explorer shall not be deemed to have
47 been appointed, as the case may be, from an eligible list on which such
48 explorer is allowed additional credit, and such appointment shall not
49 affect such explorer's eligibility for additional credit in other exam-
50 inations.

51 4. An application for additional credit in a competitive examination
52 under this section may be withdrawn by the applicant at any time prior
53 to the establishment of the resulting eligible list. At any time during
54 the term of existence of an eligible list resulting from a competitive
55 examination in which a Nassau county law enforcement explorer has
56 received the additional credit granted by this section, such Nassau

1 county law enforcement explorer may elect, prior to permanent original
2 appointment, to relinquish the additional credit granted and accept the
3 lower position on such eligible list to which such explorer would other-
4 wise have been entitled; provided, however, that such election shall
5 thereafter be irrevocable. Such election shall be in writing and signed
6 by the Nassau county law enforcement explorer, and transmitted to the
7 department or the appropriate municipal civil service commission.

8 5. The department and each municipal commission shall establish and
9 maintain in its office a roster of all such Nassau county law enforce-
10 ment explorers appointed as a result of additional credits granted by
11 this section to positions under its jurisdiction. The appointment of a
12 Nassau county law enforcement explorer as a result of additional credits
13 shall be void if such Nassau county law enforcement explorer, prior to
14 such appointment, had been appointed as a result of additional credits
15 granted by this section.

16 § 3. This act shall take effect immediately.
