WHEREAS, Prior to entering high school, Ava Guilmette enjoyed a decorated wrestling career, winning six National Championships, along with a Tallin Open title (2023) and a Pan-American title (2024); and

WHEREAS, For her many achievements, Ava Guilmette has garnered a top 20 national ranking in her weight class, according to USA Wrestling, FloWrestling, and the National Wrestling Hall of Fame and Museum; and

WHEREAS, The athletic talent displayed by this scholar-athlete is due, in great part, to the efforts of a great team of coaches and skilled and inspirational tutors who are respected for their ability to develop potential into excellence; and

WHEREAS, In a sport, such as wrestling, which demands athletic prowess, speed, and agility, Head Coach Dan Palmerino and Assistant Coach Antonio Lomascolo worked hard to hone the skills of this champion, teaching this outstanding athlete lessons which will prove invaluable both on and off the mat; and
