HONORING the 33 Purple Heart recipients interred
at the New York State Veterans Cemetery-Finger
Lakes, on May 25, 2026

WHEREAS, It is the sense of this Legislative Body to recognize and pay tribute to those distinguished veterans who have served the United States of America with honor, courage, and dedication, and who have demonstrated extraordinary valor in defense of our Nation; and

WHEREAS, This Legislative Body is justly proud to honor 33 recipients of the Purple Heart who are interred at the New York State Veterans Cemetery-Finger Lakes, and to recognize their enduring legacy of sacrifice and service; and

WHEREAS, The Purple Heart, established by General George Washington during the Revolutionary War, is awarded to members of the Armed Forces who have been wounded or killed in action while serving our Nation, symbolizing their bravery, sacrifice, and unwavering commitment to liberty; and

WHEREAS, The New York State Veterans Cemetery-Finger Lakes stands as a solemn and perpetual memorial dedicated to honoring the service and sacrifice of our Nation's veterans, and serves as a place of reflection, remembrance, and gratitude for generations to come; and

WHEREAS, The Friends of the New York State Veterans Cemetery-Finger Lakes, a dedicated volunteer organization, continues to uphold the highest standards and values of this hallowed ground, ensuring that the memory of those interred there is preserved with dignity and honor; and
