WHEREAS, For 75 years, Able2 has evolved from its humble beginnings into a thriving professional agency that serves individuals with intellectual and developmental disabilities of all kinds, enhancing their potential and providing meaningful, person-centered support that allows them to live independent, fulfilling, and productive lives; and

WHEREAS, Able2's mission is rooted in the belief that all individuals with disabilities are valuable members of society and that every person has the right to pursue their dreams, ambitions, and full potential; furthermore, its comprehensive services provide people with the tools they need to succeed, promoting inclusivity, productivity, and independence throughout the Chemung County community; and

WHEREAS, Able2 is steadfast in its commitment to creating opportunities for individuals with disabilities, empowering them to be contributors to their community and raising awareness and acceptance of people with developmental disabilities; and

WHEREAS, This vital agency's core values reflect the power of partnerships between those it serves, its staff, its volunteers, and the broader community, built on ethical, responsive, and high-quality supports; and

WHEREAS, The impact of Able2's services is immeasurable, as it

continues to foster an environment in which individuals with disabilities are recognized for their strengths and supported in ways that enrich not only their lives but the lives of those around them; and
