WHEREAS, Of more than 2,400 hospitals considered for this esteemed accolade, only 36 general hospitals were successful in receiving the coveted award; Kenmore Mercy Hospital was one such hospital of the 36 in the nation, and was one of only two hospitals in New York State to be designated for this recognition; and

WHEREAS, Along with this momentous designation, Kenmore Mercy Hospital received its twenty second consecutive "A" Safety Grade, making it one of only 26 hospitals in the country, and the only one in New York with this distinction; and

WHEREAS, Proving patient safety to be the utmost priority time and time again, Kenmore Mercy Hospital is justly deserving of this 2024 Leapfrog Top Hospital Award for outstanding quality and patient safety, and merits the applause of all citizens of this great State and Nation; and
