**WHEREAS,** In 2017, Inspector Victoria Perry rose to the rank of Captain and was appointed Executive Officer of both the 94th and 79th Precincts, followed by her historic appointment in 2019 as the Commanding Officer of the 104th Precinct, where she continued to demonstrate operational leadership and community commitment; and

**WHEREAS,** Inspector Victoria Perry is a proud graduate of John Jay College of Criminal Justice, having earned both her undergraduate and graduate degrees, and further distinguished herself nationally as an alumnus of the prestigious FBI National Academy; and

**WHEREAS,** Throughout her career, Inspector Victoria Perry has exemplified excellence in both patrol and administrative assignments, displaying a rare blend of operational expertise and strategic insight,

making her a model of leadership within the NYPD and a trusted bridge between law enforcement and the communities it serves; and
