AN ACT to amend the public health law, in relation to expanding the
Doctors Across New York program to include dentists

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph (c) of subdivision 5-a of section 2807-m of the
2 public health law, as amended by section 6 of part C of chapter 57 of
3 the laws of 2023, is amended to read as follows:
4 (c) Physician and dentist loan repayment program. One million nine
5 hundred sixty thousand dollars for the period January first, two thou-
6 sand eight through December thirty-first, two thousand eight, one
7 million nine hundred sixty thousand dollars for the period January
8 first, two thousand nine through December thirty-first, two thousand
9 nine, one million nine hundred sixty thousand dollars for the period
10 January first, two thousand ten through December thirty-first, two thou-
11 sand ten, four hundred ninety thousand dollars for the period January
12 first, two thousand eleven through March thirty-first, two thousand
13 eleven, one million seven hundred thousand dollars each state fiscal
14 year for the period April first, two thousand eleven through March thir-
15 ty-first, two thousand fourteen, up to one million seven hundred five
16 thousand dollars each state fiscal year for the period April first, two
17 thousand fourteen through March thirty-first, two thousand seventeen, up
18 to one million seven hundred five thousand dollars each state fiscal
19 year for the period April first, two thousand seventeen through March
20 thirty-first, two thousand twenty, up to one million seven hundred five
21 thousand dollars each state fiscal year for the period April first, two
22 thousand twenty through March thirty-first, two thousand twenty-three,
23 and up to one million seven hundred five thousand dollars each state
24 fiscal year for the period April first, two thousand twenty-three

1 through March thirty-first, two thousand twenty-six, shall be set aside
2 and reserved by the commissioner from the regional pools established
3 pursuant to subdivision two of this section and shall be available for
4 purposes of physician and dentist loan repayment in accordance with
5 subdivision ten of this section. Notwithstanding any contrary provision
6 of this section, sections one hundred twelve and one hundred sixty-three
7 of the state finance law, or any other contrary provision of law, such
8 funding shall be allocated regionally with one-third of available funds
9 going to New York city and two-thirds of available funds going to the
10 rest of the state and shall be distributed in a manner to be determined
11 by the commissioner without a competitive bid or request for proposal
12 process as follows:

13 (i) Funding shall first be awarded to repay loans of up to twenty-five
14 physicians who train in primary care or specialty tracks in teaching
15 general hospitals, and who enter and remain in primary care or specialty
16 practices in underserved communities, as determined by the commissioner.

17 (ii) After distributions in accordance with subparagraph (i) of this
18 paragraph, all remaining funds shall be awarded to repay loans of physi-
19 cians or dentists who enter and remain in primary care or specialty
20 practices in underserved communities, as determined by the commissioner,
21 including but not limited to physicians or dentists working in general
22 hospitals, or other health care facilities.

23 (iii) In no case shall less than fifty percent of the funds available
24 pursuant to this paragraph be distributed in accordance with subpara-
25 graphs (i) and (ii) of this paragraph to physicians or dentists identi-
26 fied by general hospitals.

27 (iv) In addition to the funds allocated under this paragraph, for the
28 period April first, two thousand fifteen through March thirty-first, two
29 thousand sixteen, two million dollars shall be available for the
30 purposes described in subdivision ten of this section;

31 (v) In addition to the funds allocated under this paragraph, for the
32 period April first, two thousand sixteen through March thirty-first, two
33 thousand seventeen, two million dollars shall be available for the
34 purposes described in subdivision ten of this section;

35 (vi) Notwithstanding any provision of law to the contrary, and subject
36 to the extension of the Health Care Reform Act of 1996, sufficient funds
37 shall be available for the purposes described in subdivision ten of this
38 section in amounts necessary to fund the remaining year commitments for
39 awards made pursuant to subparagraphs (iv) and (v) of this paragraph.

40 § 2. Paragraph (d) of subdivision 5-a of section 2807-m of the public
41 health law, as amended by section 6 of part C of chapter 57 of the laws
42 of 2023, is amended to read as follows:

43 (d) Physician and dentist practice support. Four million nine hundred
44 thousand dollars for the period January first, two thousand eight
45 through December thirty-first, two thousand eight, four million nine
46 hundred thousand dollars annually for the period January first, two
47 thousand nine through December thirty-first, two thousand ten, one
48 million two hundred twenty-five thousand dollars for the period January
49 first, two thousand eleven through March thirty-first, two thousand
50 eleven, four million three hundred thousand dollars each state fiscal
51 year for the period April first, two thousand eleven through March thir-
52 ty-first, two thousand fourteen, up to four million three hundred sixty
53 thousand dollars each state fiscal year for the period April first, two
54 thousand fourteen through March thirty-first, two thousand seventeen, up
55 to four million three hundred sixty thousand dollars for each state
56 fiscal year for the period April first, two thousand seventeen through

1 March thirty-first, two thousand twenty, up to four million three
2 hundred sixty thousand dollars for each fiscal year for the period April
3 first, two thousand twenty through March thirty-first, two thousand
4 twenty-three, and up to four million three hundred sixty thousand
5 dollars for each fiscal year for the period April first, two thousand
6 twenty-three through March thirty-first, two thousand twenty-six, shall
7 be set aside and reserved by the commissioner from the regional pools
8 established pursuant to subdivision two of this section and shall be
9 available for purposes of physician and dentist practice support.
10 Notwithstanding any contrary provision of this section, sections one
11 hundred twelve and one hundred sixty-three of the state finance law, or
12 any other contrary provision of law, such funding shall be allocated
13 regionally with one-third of available funds going to New York city and
14 two-thirds of available funds going to the rest of the state and shall
15 be distributed in a manner to be determined by the commissioner without
16 a competitive bid or request for proposal process as follows:

17 (i) Preference in funding shall first be accorded to teaching general
18 hospitals for up to twenty-five awards, to support costs incurred by
19 physicians or dentists trained in primary or specialty tracks who there-
20 after establish or join practices in underserved communities, as deter-
21 mined by the commissioner.

22 (ii) After distributions in accordance with subparagraph (i) of this
23 paragraph, all remaining funds shall be awarded to physicians or
24 dentists to support the cost of establishing or joining practices in
25 underserved communities, as determined by the commissioner, and to
26 hospitals and other health care providers to recruit new physicians or
27 dentists to provide services in underserved communities, as determined
28 by the commissioner.

29 (iii) In no case shall less than fifty percent of the funds available
30 pursuant to this paragraph be distributed to general hospitals in
31 accordance with subparagraphs (i) and (ii) of this paragraph.

32 § 3. Subdivision 10 of section 2807-m of the public health law, as
33 added by section 75-e of part C of chapter 58 of the laws of 2008, para-
34 graphs (a) and (c) as amended by section 13 of part B of chapter 58 of
35 the laws of 2010, is amended to read as follows:

36 10. Physician and dentist loan repayment program. (a) Beginning Janu-
37 ary first, two thousand eight, the commissioner is authorized, within
38 amounts available pursuant to subdivision five-a of this section, to
39 make loan repayment awards to primary care physicians and dentists or
40 other physician and dentist specialties determined by the commissioner
41 to be in short supply, licensed to practice medicine or dentistry in New
42 York state, who agree to practice for at least five years in an under-
43 served area, as determined by the commissioner. Such physician or
44 dentist shall be eligible for a loan repayment award of up to one
45 hundred fifty thousand dollars over a five year period distributed as
46 follows: fifteen percent of total loan debt not to exceed twenty thou-
47 sand dollars for the first year; fifteen percent of total loan debt not
48 to exceed twenty-five thousand dollars for the second year; twenty
49 percent of total loan debt not to exceed thirty-five thousand dollars
50 for the third year; and twenty-five percent of total loan debt not to
51 exceed thirty-five thousand dollars per year for the fourth year; and
52 any unpaid balance of the total loan debt not to exceed the maximum
53 award amount for the fifth year of practice in such area.

54 (b) Loan repayment awards made to a physician or dentist pursuant to
55 paragraph (a) of this subdivision shall not exceed the total qualifying
56 outstanding debt of the physician or dentist from student loans to cover

1 tuition and other related educational expenses, made by or guaranteed by
2 the federal or state government, or made by a lending or educational
3 institution approved under title IV of the federal higher education act.
4 Loan repayment awards shall be used solely to repay such outstanding
5 debt.

6 (c) In the event that a five-year commitment pursuant to the agreement
7 referenced in paragraph (a) of this subdivision is not fulfilled, the
8 recipient shall be responsible for repayment in amounts which shall be
9 calculated in accordance with the formula set forth in subdivision (b)
10 of section two hundred fifty-four-o of title forty-two of the United
11 States Code, as amended.

12 (d) The commissioner is authorized to apply any funds available for
13 purposes of paragraph (a) of this subdivision for use as matching funds
14 for federal grants for the purpose of assisting states in operating loan
15 repayment programs pursuant to section three hundred thirty-eight I of
16 the public health service act.

17 (e) The commissioner may postpone, change or waive the service obli-
18 gation and repayment amounts set forth in paragraphs (a) and (c),
19 respectively of this subdivision in individual circumstances where there
20 is compelling need or hardship.

21 (f)(i) When a physician or dentist is not actually practicing in an
22 underserved area, [~~he or she~~] such physician or dentist shall be deemed
23 to be practicing in an underserved area if [~~he or she practices~~] they
24 practice in a facility or physician's or dentist's office that primarily
25 serves an underserved population as determined by the commissioner,
26 without regard to whether the population or the facility or physician's
27 or dentist's office is located in an underserved area.

28 (ii) In making criteria and determinations as to whether an area is an
29 underserved area or whether a facility or physician's or dentist's
30 office primarily serves an underserved population, the commissioner may
31 make separate criteria and determinations for different specialties.

32 § 4. This act shall take effect immediately.
