AN ACT to amend the real property tax law, in relation to the payment of real property and school district taxes in installments; and to amend a chapter of the laws of 2024 amending the real property tax law relating to the payment of real property and school district taxes in installments, as proposed in legislative bills numbers S. 3604-A and A. 7813-A, in relation to the effectiveness thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subparagraph (xv) of paragraph (a) of subdivision 1 of  
2 section 922 of the real property tax law, as added by a chapter of the  
3 laws of 2024 amending the real property tax law relating to the payment  
4 of real property and school district taxes in installments, as proposed  
5 in legislative bills numbers S. 3604-A and A. 7813-A, is amended to read  
6 as follows:

7 (xv) notwithstanding any general, special or local law to the contra-  
8 ry, if [~~the owner has elected to pay~~] the taxes set forth in the state-  
9 ment are payable in installments[~~, pursuant to this article,~~] such  
10 statement shall clearly disclose the due dates for payment of such  
11 [~~installment payments~~] installments without interest or penalties.

12 § 2. Subdivision 2 of section 974 of the real property tax law, as  
13 amended by a chapter of the laws of 2024 amending the real property tax  
14 law relating to the payment of real property and school district taxes  
15 in installments, as proposed in legislative bills numbers S. 3604-A and  
16 A. 7813-A, is amended to read as follows:

28 S. 3604-A and A. 7813-A, is amended to read as follows:

29 § 4. This act shall take effect [~~immediately~~] on the one hundred twen-  
30 tieth day after it shall have become a law.

31 § 5. This act shall take effect immediately and shall be deemed to  
32 have been in full force and effect on and after September 27, 2024;  
33 provided however, that sections one, two and three of this act shall  
34 take effect on the same date and in the same manner as a chapter of the  
35 laws of 2024 amending the real property tax law relating to the payment  
36 of real property and school district taxes in installments, as proposed  
37 in legislative bills numbers S. 3604-A and A. 7813-A.
