AN ACT in relation to authorizing the commissioner of education to conduct a survey regarding instruction on Asian American, Native Hawaiians and Pacific Islander history within the state; and to amend the education law, in relation to establishing an Asian American, Native Hawaiians and Pacific Islander history advisory committee; and providing for the repeal of such provisions upon the expiration thereof

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. (a) The commissioner of education is authorized and  
2 directed to conduct a survey regarding instruction on Asian American,  
3 Native Hawaiians and Pacific Islander (AANHPI) history within the state.  
4 Such survey shall focus on identifying which school districts provide  
5 instruction on Asian American, Native Hawaiians and Pacific Islander  
6 (AANHPI) history. Such survey shall include as appropriate, questions  
7 on how the district is providing such instruction, including, but not  
8 limited to, the following:  
9 (1) how do the department's learning standards inform the school  
10 district's teaching of AANHPI history;  
11 (2) which grade levels are being taught about AANHPI topics;  
12 (3) how much instructional time is devoted to AANHPI topics;  
13 (4) what are the school district's social studies curricula that are  
14 used in the district, and who publishes curricula;  
15 (5) what challenges and/or barriers do educators face in incorporating  
16 AANHPI topics into the curriculum;  
17 (6) do educators receive any training or professional development  
18 regarding AANHPI topics; and

1 (7) are there assessments or evaluations to measure student under-  
2 standing of AANHPI topics.

3 (b) Findings shall include detailed results of the survey, and if  
4 needed, recommendations to implement or strengthen such instruction. A  
5 report of the findings of such survey shall be delivered to the gover-  
6 nor, the temporary president of the senate, the speaker of the assembly,  
7 the minority leader of the senate and the minority leader of the assem-  
8 bly the first of January following the effective date of this act or one  
9 hundred twenty days after the effective date of this act, whichever is  
10 later.

11 § 2. The education law is amended by adding a new section 805 to read  
12 as follows:

13 § 805. Asian American, Native Hawaiians and Pacific Islander history  
14 advisory committee; appointment; powers and duties. 1. Contingent upon  
15 appropriation for such, the commissioner shall establish an Asian Ameri-  
16 can, Native Hawaiians and Pacific Islander (AANHPI) history advisory  
17 committee.

18 2. (a) The committee shall be comprised of four members, to be  
19 appointed as follows:

20 (i) one member appointed by the governor;

21 (ii) one member appointed by the temporary president of the senate;

22 (iii) one member appointed by the speaker of the assembly; and

23 (iv) one member appointed by the commissioner.

24 (b) All members appointed to the committee shall be experts in Asian  
25 American, Native Hawaiians and/or Pacific Islander studies and/or have a  
26 background in educational instruction and or educational administration.

27 (c) All members of the committee shall be appointed within ninety days  
28 of the effective date of this section.

29 3. Vacancies in the membership of the committee shall be filled in the  
30 same manner provided for original appointments.

31 4. The committee shall meet no less than four times per year.

32 5. The committee shall have the powers and duties to:

33 (a) evaluate the extent to which AANHPI content is incorporated into  
34 current state learning standards;

35 (b) evaluate the current ways AANHPI history is taught in classrooms;  
36 and

37 (c) make recommendations on how to include AANHPI content into the  
38 state learning standards, key aspects of the subject matter that should  
39 be included in the instruction, and ways to integrate AANHPI history  
40 into existing courses.

41 6. The committee shall submit a written report to the commissioner no  
42 later than two years after the effective date of this section detailing  
43 its findings and recommendations.

44 7. Committee members shall receive no compensation for their services,  
45 but shall be allowed their actual and necessary expenses incurred in the  
46 performance of their duties.

47 8. To effectuate the purposes of this section, the committee may  
48 request from any department, board, bureau, commission or other agency  
49 of the state, and the same are authorized to provide, such cooperation  
50 and assistance, services and data as will enable the committee to prop-  
51 erly carry out its functions pursuant to this section.

52 § 3. This act shall take effect immediately; and shall expire and be  
53 deemed repealed three years after such effective date.
