AN ACT in relation to authorizing the county of Putnam to alienate certain lands used as parklands

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subject to the provisions of this act, the county of
2 Putnam, acting by and through its governing body and upon such terms and
3 conditions as determined by such board is hereby authorized to discon-
4 tinue as parklands and alienate the lands described in section three of
5 this act to Homeland Towers, LLC for the purposes of installing a 160
6 foot cellular tower with associated equipment shelter, backup genera-
7 tors, and telecommunications equipment.

8 § 2. The authorization provided in section one of this act shall be
9 effective only upon the condition that the county of Putnam dedicate an
10 amount equal to or greater than the fair market value of the parklands
11 being discontinued toward the acquisition of new parklands and/or capi-
12 tal improvements to existing park and recreational facilities.

13 § 3. The parklands authorized by section one of this act to be alien-
14 ated are described as follows:

15 Parcel 1:

16 SITUATED IN THE TOWN OF CARMEL, COUNTY OF PUTNAM AND STATE OF NEW YORK:

33 § 4. In the event that the county of Putnam received any funding
34 support or assistance from the federal government for the purchase,
35 maintenance or improvement of the parklands set forth in section three
36 of this act, the discontinuance and alienation of such parkland author-
37 ized by the provisions of this act shall not occur until Putnam county
38 has complied with any federal requirements pertaining to the alienation
39 or conversion of parklands, including satisfying the secretary of the
40 interior that the alienation or conversion complies with all conditions
41 which the secretary of the interior deems necessary to assure the
42 substitution of other lands shall be equivalent in fair market value and
43 usefulness to the lands being alienated or converted.
