AN ACT to amend the workers' compensation law, in relation to providing for paid family leave following a stillbirth

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Subdivision 15 of section 201 of the workers' compensation  
2 law, as added by section 2 of part SS of chapter 54 of the laws of 2016,  
3 is amended to read as follows:  
4 15. "Family leave" shall mean any leave taken by an employee from  
5 work: (a) to participate in providing care, including physical or  
6 psychological care, for a family member of the employee made necessary  
7 by a serious health condition of the family member; ~~(b)~~ (b) to bond  
8 with the employee's child during the first twelve months after the  
9 child's birth, or the first twelve months after the placement of the  
10 child for adoption or foster care with the employee; ~~(c)~~ (c) to recover  
11 after a stillbirth; or (d) because of any qualifying exigency as inter-  
12 preted under the family and medical leave act, 29 U.S.C.S §  
13 2612(a)(1)(e) and 29 C.F.R. S.825.126(a)(1)-(8), arising out of the fact  
14 that the spouse, domestic partner, child, or parent of the employee is

1 on active duty (or has been notified of an impending call or order to  
2 active duty) in the armed forces of the United States.  
3 § 2. This act shall take effect on the first of January following the  
4 first of September next succeeding the date on which it shall have  
5 become a law and shall apply to all policies or contracts issued,  
6 renewed, modified, altered or amended on or after such date.
