AN ACT to amend the executive law, in relation to awards made to crime victims

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 8 of section 621 of the executive law, as added by chapter 197 of the laws of 1983, is amended to read as follows:

8. "Essential personal property" shall mean articles of personal property necessary and essential to the health, welfare or safety of the victim.

(a) Personal property necessary and essential to the welfare of the victim shall mean personal property of a victim that is lost, damaged, or stolen as a result of a crime and for which reimbursement or replacement is reasonably necessary for the victim to restore stability or maintain a reasonable and/or basic standard of living.

(b) The office shall promulgate rules and regulations for the determination and approval of what constitutes property reasonably necessary to restore or maintain a reasonable and/or basic standard of living consistent with this article.

§ 2. Subdivision 9 of section 631 of the executive law is amended by adding four new paragraphs (c), (d), (e) and (f) to read as follows:

(c) For property necessary and essential to the welfare of the victim, the office may request that the claimant provide estimates or receipts for personal property lost, damaged or stolen as a result of the crime. A claimant's inability to produce a receipt for lost, stolen or damaged personal items shall not in itself disqualify a claimant from receiving

1 reimbursement for such items. The office shall consider all the facts
2 and circumstances of each case before making a determination.

3 (d) Personal property necessary and essential to the welfare of the
4 victim shall include, but not be limited to, the following items lost,
5 damaged, or stolen as a result of the crime:

6 (i) clothing;

7 (ii) shoes;

8 (iii) furniture;

9 (iv) appliances;

10 (v) electronics; and

11 (vi) bedding.

12 (e) Property necessary and essential to the welfare of the victim
13 shall include, but not be limited to, the following:

14 (i) Sofa, couch, loveseat, or chair;

15 (ii) Dining table;

16 (iii) Bed/mattress;

17 (iv) Sheets, pillows, comforters and blankets;

18 (v) Lamp;

19 (vi) Refrigerator;

20 (vii) Microwave;

21 (viii) Stove;

22 (ix) Dishes and eating utensils;

23 (x) Television;

24 (xi) Telephone or cell phone;

25 (xii) Toys for children under six years old; and

26 (xiii) Stroller.

27 (f) Eligible essential personal property as specified in paragraph (e)
28 of this subdivision, including any property not specifically enumerated
29 in paragraph (e) of this subdivision, may be reimbursed at a reasonable
30 rate as determined by the office, provided that such rate does not
31 exceed twenty-five hundred dollars.

32 § 3. This act shall take effect immediately.
