AN ACT to amend the education law and the public health law, in relation to prescription labels for gonadotropin-releasing hormone agonists, pubertal suppressants, anabolic steroids, alpha reductase inhibitors, progestins, or drug classes for hormone replacement therapy for treatment of gender dysphoria

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Paragraph b-1 of subdivision 1 of section 6807 of the education law, as amended by chapter 108 of the laws of 2025, is amended to read as follows:

b-1. Notwithstanding paragraph b of this ~~[section]~~ subdivision, the prescription label for mifepristone ~~[or]~~ misoprostol, gonadotropin-releasing hormone agonists, pubertal suppressants, anabolic steroids, alpha reductase inhibitors, progestins, or drug classes for hormone replacement therapy for treatment of gender dysphoria, may include the name or address of the dispensing health care practice instead of the name of the dispenser.

§ 2. Subdivision 1-a of section 6810 of the education law, as amended by chapter 108 of the laws of 2025, is amended to read as follows:

1-a. Notwithstanding subdivision one of this section, at the prescriber's request, the prescription label for mifepristone ~~[or]~~ misoprostol, gonadotropin-releasing hormone agonists, pubertal suppressants, anabolic steroids, alpha reductase inhibitors, progestins, or drug classes for hormone replacement therapy for treatment of gender

8 health care practice instead of the name of such prescriber on the
9 prescription label when prescribing mifepristone ~~[or]~~, misoprostol,
10 gonadotropin-releasing hormone agonists, pubertal suppressants, anabolic
11 steroids, alpha reductase inhibitors, progestins, or drug classes for
12 hormone replacement therapy for treatment of gender dysphoria.
