Introduced by M. of A. BUTTENSCHON -- read once and referred to the Committee on Environmental Conservation

AN ACT to amend the environmental conservation law, in relation to enacting the "dollars for diesels act" relating to financial incentives for the retirement of certain heavy- and medium-duty vehicles

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Short title. This act shall be known and may be cited as
2 the "dollars for diesels act".

3 § 2. The environmental conservation law is amended by adding a new
4 section 19-0333 to read as follows:

5 § 19-0333. Dollars for diesels program.

6 1. Definitions: When used in this section:

7 a. "Heavy-duty vehicle" means any vehicle powered by diesel fuel
8 having a gross weight of greater than twenty-six thousand pounds.

9 b. "Medium-duty vehicle" means any vehicle powered by diesel fuel
10 having a gross weight of greater than fourteen thousand pounds but no
11 more than twenty-six thousand pounds.

12 2. The commissioner, in consultation with the New York state energy
13 research and development authority, shall establish and administer a
14 program to provide financial incentives to owners of heavy- and medium-
15 duty vehicles of a model year two thousand ten or older to retire and
16 replace such vehicles with new heavy- or medium-duty vehicles of model
17 year two thousand twenty-four or newer that meet or exceed the applica-
18 ble emission standards.

19 3. For a vehicle to be eligible for the vehicle retirement incentive
20 under this section, such vehicle shall be a heavy-duty vehicle or a
21 medium-duty vehicle, and shall have been registered in the state of New
22 York for at least three consecutive years preceding the model year of
23 the replacement vehicle. Registration shall be continuous and active,
24 with the vehicle in operable condition and part of a functioning fleet.

1 4. Incentives may include direct cash payments, grants, or vouchers
2 payable upon proof of vehicle retirement and replacement as specified by
3 the department and the New York state energy research and development
4 authority.

5 5. The program shall utilize existing state and federal funds allo-
6 cated to the department and the New York state energy research and
7 development authority for diesel emissions reduction and clean transpor-
8 tation initiatives.

9 6. The commissioner and the New York state energy research and devel-
10 opment authority shall promulgate regulations or guidelines as necessary
11 to implement this section, including eligibility criteria, funding
12 amounts, and program administration.

13 7. The commissioner shall report annually to the governor and the
14 legislature on program outcomes.

15 § 3. This act shall take effect immediately.
