CONCURRENT RESOLUTION OF THE SENATE AND ASSEMBLY

proposing an amendment to article 5 of the constitution, relating to the filling of vacancies in the offices of comptroller and attorney-general

1 Section 1. Resolved (if the Assembly concur), That section 1 of article 5 of the constitution be amended to read as follows:

2 Section 1. The comptroller and attorney-general shall be chosen at the
3 same general election as the governor and hold office for the same term,
4 and shall possess the qualifications provided in section 2 of article
5 IV. The legislature shall provide for filling vacancies in the office of
6 comptroller and of attorney-general until the next general election
7 happening not less than three months after the office shall have become
8 vacant, at which time a comptroller or attorney-general shall be elected
9 to serve the remainder of the term. [~~No election of a comptroller or an~~
10 ~~attorney-general shall be had except at the time of electing a gover-~~
11 ~~nor.~~] In case the comptroller-elect or attorney-general-elect shall
12 decline to serve or shall die, the legislature shall provide for filling
13 the vacancy until the next general election. The comptroller shall be
14 required: (1) to audit all vouchers before payment and all official
15 accounts; (2) to audit the accrual and collection of all revenues and
16 receipts; and (3) to prescribe such methods of accounting as are neces-
17 sary for the performance of the foregoing duties. The payment of any
18 money of the state, or of any money under its control, or the refund of
19 any money paid to the state, except upon audit by the comptroller, shall
20 be void, and may be restrained upon the suit of any taxpayer with the
21 consent of the supreme court in appellate division on notice to the
22 attorney-general. In such respect the legislature shall define the
23 powers and duties and may also assign to [~~him or her~~] the comptroller:
24 (1) supervision of the accounts of any political subdivision of the
25 state; and (2) powers and duties pertaining to or connected with the

1 assessment and taxation of real estate, including determination of
2 ratios which the assessed valuation of taxable real property bears to
3 the full valuation thereof, but not including any of those powers and
4 duties reserved to officers of a county, city, town or village by virtue
5 of [~~sections seven and eight of~~] article nine of this constitution. The
6 legislature shall assign to [~~him or her~~] the comptroller no administra-
7 tive duties, excepting such as may be incidental to the performance of
8 these functions, any other provision of this constitution to the contra-
9 ry notwithstanding.

10 § 2. Resolved (if the Assembly concur), That the foregoing amendment
11 be referred to the first regular legislative session convening after the
12 next succeeding general election of members of the assembly, and, in
13 conformity with section 1 of article 19 of the constitution, be
14 published for 3 months previous to the time of such election.
