AN ACT to amend the mental hygiene law and the administrative code of the city of New York, in relation to enacting the "New York City Training and Comprehension of Trauma in Children (TACTIC) Act"

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Short title. This act shall be known and may be cited as
2 the "New York City Training and Comprehension of Trauma in Children
3 (TACTIC) Act".

4 § 2. The mental hygiene law is amended by adding a new section 7.51 to
5 read as follows:

6 § 7.51 New York city training and comprehension of trauma in children
7 (TACTIC) council.

8 (a) For purposes of this section the following terms shall have the
9 following meanings:

10 1. "Trauma informed care" shall mean trauma informed care as described
11 by the substance abuse and mental health services administration of the
12 United States department of health and human services, or any successor
13 agency, department, or governmental entity.

14 2. "Teacher" shall mean all persons engaged in classroom teaching of
15 students, on a full-time or part-time basis, including but not limited
16 to, instructors, counselors, assistants or aides.

17 (b) (i) There is hereby established within the office a New York city
18 training and comprehension of trauma in children (TACTIC) council.

19 (ii) The TACTIC council shall consist of eight members, four of whom
20 shall be appointed by the speaker of the assembly and four of whom shall
21 be appointed by the temporary president of the senate. Of the four
22 members appointed by the speaker of the assembly, one shall be a pedia-
23 trician, one shall be a child psychologist and two shall be trauma

1 informed care specialists. Of the four members appointed by the tempo-
2 rary president of the senate, one shall be a behavioral health special-
3 ist, one shall be a neurologist and two shall be trauma informed care
4 specialists.

5 (iii) The office, in conjunction with the TACTIC council and the New
6 York city department of child trauma informed care shall:

7 (1) provide an annual trauma informed care training program to teach-
8 ers in schools located in the city of New York. Such program shall
9 include training and instruction led by a district trauma informed care
10 specialist, including, but not be limited to, understanding the effects
11 of trauma on students, recognizing the signs and symptoms of trauma in
12 students and learning best practices for assisting and supporting
13 students who are experiencing or have experienced trauma;

14 (2) establish a mandatory trauma informed care certification program
15 for teachers. Such program shall be conducted through an online platform
16 over a span of six to nine months; and

17 (3) establish, in conjunction with the department of child trauma
18 informed care, monthly trauma informed care parenting workshops, to
19 assist parents of children who are experiencing or have experienced
20 trauma. Such workshops shall be offered by the city school district of
21 the city of New York and shall be led by district trauma informed care
22 specialists.

23 (c) The TACTIC council shall review the information provided by the
24 department of child trauma informed care pursuant to paragraph two of
25 subdivision b of section 21-970 of the administrative code of the city
26 of New York and shall report to the office and the state legislature
27 with recommendations to effectively implement and improve child trauma
28 informed care provided in schools.

29 § 3. Title 21-A of the administrative code of the city of New York is
30 amended by adding a new chapter 8-A to read as follows:

31 CHAPTER 8-A

32 DEPARTMENT OF CHILD TRAUMA INFORMED CARE

33 § 21-970 Department of child trauma informed care.

34 a. There is hereby established within the department, a department of
35 child trauma informed care.

36 b. The department of child trauma informed care shall:

37 1. Assist in establishing trauma informed care parenting workshops
38 pursuant to section 7.51 of the mental hygiene law.

39 2. Compile and report to the training and comprehension of trauma in
40 children council, pursuant to section 7.51 of the mental hygiene law, on
41 child trauma informed care provided to schools within the city school
42 district, including, but not limited to, providing information regarding
43 school involvement, the number of students identified as experiencing
44 trauma, details of teacher certification, trauma incidents occurring in
45 schools and parental assistance provided.

46 3. Administer the mandatory trauma informed care certification program
47 for all teachers within the city school district.

48 4. Assign trauma informed care specialists to each borough superinten-
49 dent's office to supervise district trauma informed care specialists.

50 5. Assign district trauma informed care specialists to each school
51 located within the city school district to implement the annual trauma
52 informed care training program to teachers and to present the parenting
53 workshops within the district. Such district trauma informed care
54 specialists shall report to the trauma informed care specialists
55 assigned to each borough superintendent's office.

56 § 4. This act shall take effect immediately.
