Introduced by Sens. JACKSON, BAILEY, FERNANDEZ, SEPULVEDA, WEBB -- read twice and ordered printed, and when printed to be committed to the Committee on Elections -- recommitted to the Committee on Elections in accordance with Senate Rule 6, sec. 8 -- reported favorably from said committee, ordered to first and second report, ordered to a third reading, amended and ordered reprinted, retaining its place in the order of third reading -- again amended and ordered reprinted, retaining its place in the order of third reading

AN ACT to amend the election law, in relation to including a statement on the envelopes of ballots for early mail voters, absentee voters and special presidential voters for signature affirmation

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subdivision 6 of section 7-119 of the election law, as added by chapter 481 of the laws of 2023, is amended to read as follows:  
6. On the reverse side of such inner affirmation envelope shall be printed the following statement:

### AFFIRMATION

I do declare that I am a citizen of the United States, that I am duly registered in the election district shown on the reverse side of this envelope and I am qualified to vote in such district; that I have not qualified nor do I intend to vote elsewhere, that I have not committed any act nor am I under any impediment which denies me the right to vote.

I hereby declare that the foregoing is a true statement to the best of my knowledge and belief, and I understand that if I make any material false statement in the foregoing statement of early mail voter, I shall be guilty of a misdemeanor.

11 § 2. Subdivision 6 of section 7-122 of the election law, as amended by  
 12 chapter 411 of the laws of 2019, is amended to read as follows:

13 6. On the reverse side of such inner affirmation envelope shall be  
 14 printed the following statement:

15 **AFFIRMATION**

16 I do declare that I am a citizen of the United States, that I am duly  
 17 registered in the election district shown on the reverse side of this  
 18 envelope and I am qualified to vote in such district; that I will be  
 19 unable to appear personally on the day of the election for which this  
 20 ballot is voted at the polling place of the election district in which I  
 21 am a qualified voter because of the reason given on my application here-  
 22 tofore submitted; that I have not qualified nor do I intend to vote  
 23 elsewhere, that I have not committed any act nor am I under any imped-  
 24 iment which denies me the right to vote.

25 I hereby declare that the foregoing is a true statement to the best of  
 26 my knowledge and belief, and I understand that if I make any material  
 27 false statement in the foregoing statement of absentee voter, I shall be  
 28 guilty of a misdemeanor.

38 § 3. Subdivision 3 of section 7-125 of the election law, as amended by  
 39 chapter 411 of the laws of 2019, is amended to read as follows:

40 3. On the reverse side of such envelope shall be printed the follow-  
 41 ing statement:

42 **STATEMENT OF SPECIAL PRESIDENTIAL VOTER**

43 I do declare I am a qualified special presidential voter of said  
 44 district; that I am not qualified and am not able to qualify to vote  
 45 elsewhere than as set forth on the reverse side of this envelope; that I  
 46 am a citizen of the United States; that on the date of the election for  
 47 which this ballot is voted, I will be at least eighteen years of age;

1 and that I have not committed any act, nor am I under any impediment,  
2 which denies me the right to vote.  
3 I hereby declare that the foregoing is a true statement to the best of  
4 my knowledge and belief, and I understand that if I make any material  
5 false statement in the foregoing statement, I shall be guilty of a  
6 misdemeanor.
