AN ACT to amend the executive law, the general municipal law and the town law, in relation to requiring the inclusion of cultural competency training in the basic training and pre-employment course curriculums for state police officers and municipal police officers and sheriffs; to amend the general municipal law, in relation to requiring the inclusion of cultural competency training in the basic training and pre-employment course curricula for members of fire departments and companies; to amend the correction law, in relation to requiring the inclusion of cultural competency training in the basic training and pre-employment course curricula for correction officers; and to amend the public health law, in relation to requiring the inclusion of cultural competency training in the basic training and pre-employment course curricula for career first responders, emergency medical technicians and advanced emergency medical technicians

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- 1 Section 1. The executive law is amended by adding a new section 214-j
- 2 to read as follows:
- 3 § 214-j. Training. 1. The superintendent shall establish policies and
- 4 procedures requiring that state police basic training and pre-employment

1 course curricula include training in the areas of cultural competency,
2 including training pertaining to appropriate sensitivity to issues of
3 race, ethnicity, gender, sexual orientation, religion, age and disabili-
4 ties. Such training shall comprise not less than five percent of the
5 basic training and pre-employment course training curricula. Cultural
6 competency training shall be provided by an accredited educator and/or
7 accreditation body.

8 2. The accreditation body shall provide information pertaining to such
9 policies and procedures to municipal law enforcement agencies and
10 departments, fire departments, the department of corrections and commu-
11 nity supervision and the department of health for implementation of such
12 curricula by such agencies and departments.

13 3. The superintendent of the state police shall promulgate rules and
14 regulations necessary to effectuate the provisions of this section.

15 4. For the purposes of this section, the term "cultural competency"
16 means knowledge and skills that enable a person to appreciate, under-
17 stand and interact with members of diverse populations within the local
18 community.

19 § 2. The general municipal law is amended by adding a new section
20 208-i to read as follows:

21 § 208-i. Mandatory police officer cultural competency training. The
22 chief officer of every police department and sheriff's office in the
23 state shall establish and implement basic training and pre-employment
24 course curricula for all members of such office or department and for
25 all current and new officer employees in accordance with the cultural
26 competency policies and procedures established pursuant to section two
27 hundred fourteen-j of the executive law.

28 § 3. Section 204-d of the general municipal law, as amended by section
29 44 of part B of chapter 56 of the laws of 2010, is amended to read as
30 follows:

31 § 204-d. Duties of the fire chief. 1. The fire chief of any fire
32 department or company shall, in addition to any other duties assigned to
33 ~~[him]~~ such fire chief by law or contract, to the extent reasonably
34 possible determine or cause to be determined the cause of each fire or
35 explosion which the fire department or company has been called to
36 suppress. ~~[He]~~ Such fire chief shall file with the office of fire
37 prevention and control a report containing such determination and any
38 additional information required by such office regarding the fire or
39 explosion. The report shall be in the form designated by such office.
40 ~~[He]~~ Such fire chief shall contact or cause to be contacted the appro-
41 priate investigatory authority if ~~[he]~~ such fire chief has reason to
42 believe the fire or explosion is of incendiary or suspicious origin. For
43 all fires that are suspected to have been ignited by a cigarette, within
44 fourteen days after completing the investigation into such fire, the
45 fire chief shall forward to the office of fire prevention and control
46 information detailing, to the extent possible: (a) the specific brand
47 and style of the cigarette suspected of having ignited such fire; (b)
48 whether the cigarette package was marked as required by subdivision six
49 of section one hundred fifty-six-c of the executive law; and (c) the
50 location and manner in which such cigarette was purchased.

51 2. The fire chief of any fire department or company in the state shall
52 establish and implement basic training and pre-employment course curric-
53 ula for all members of such fire department or company and for all
54 current and new employees in accordance with the cultural competency
55 policies and procedures established pursuant to section two hundred
56 fourteen-j of the executive law.

1 § 4. The town law is amended by adding a new section 155-a to read as
2 follows:

3 § 155-a. Mandatory police officer cultural competency training. The
4 chief officer of every police department in the state shall establish
5 and implement basic training and pre-employment course curricula for all
6 members of such office and for all current and new officer employees in
7 accordance with the cultural competency policies and procedures estab-
8 lished pursuant to section two hundred fourteen-j of the executive law.

9 § 5. The correction law is amended by adding a new section 22-b to
10 read as follows:

11 § 22-b. Mandatory correction officer cultural competency training. The
12 commissioner shall establish and implement basic training and pre-em-
13 ployment course curricula for all members of the department and for all
14 current and new officer employees in accordance with the cultural compe-
15 tency policies and procedures established pursuant to section two
16 hundred fourteen-j of the executive law.

17 § 6. Section 3002 of the public health law is amended by adding a new
18 subdivision 2-c to read as follows:

19 2-c. The commissioner, in consultation with the state emergency
20 medical services council, shall establish and implement basic training
21 and pre-employment course curricula for all current career first respon-
22 ders, emergency medical technicians and advanced emergency medical tech-
23 nicians and for all new first responders, emergency medical technicians
24 and advanced emergency medical technicians in accordance with the
25 cultural competency policies and procedures established pursuant to
26 section two hundred fourteen-j of the executive law.

27 § 7. This act shall take effect immediately.
