AN ACT to amend the retirement and social security law, in relation to service retirement benefits for members of the New York city police pension fund

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Section 505 of the retirement and social security law, as  
2 amended by chapter 18 of the laws of 2012 and subdivision d as added by  
3 section 3 of part SS of chapter 55 of the laws of 2025, is amended to  
4 read as follows:

5 § 505. Service retirement benefits; police/fire members, New York city  
6 uniformed correction/sanitation revised plan members and investigator  
7 revised plan members. a. The normal service retirement benefit for  
8 police/fire members, New York city uniformed correction/sanitation  
9 revised plan members and investigator revised plan members at normal  
10 retirement age shall be a pension equal to fifty percent of final aver-  
11 age salary, less fifty percent of the primary social security retirement  
12 benefit commencing at age sixty-two, as provided in section five hundred  
13 eleven of this article, except that for members of the New York city  
14 police pension fund, the normal service retirement benefit shall not be  
15 reduced by the primary social security retirement benefit commencing at  
16 age sixty-two as provided in section five hundred eleven of this  
17 article.

18 b. The early service retirement benefit for police/fire members, New  
19 York city uniformed correction/sanitation revised plan members and  
20 investigator revised plan members shall be a pension equal to two and

1 one-tenths percent of final average salary times years of credited  
2 service at the completion of twenty years of service or upon attainment  
3 of age sixty-two, increased by one-third of one percent of final average  
4 salary for each month of service in excess of twenty years, but not in  
5 excess of fifty percent of final average salary, less fifty percent of  
6 the primary social security retirement benefit commencing at age sixty-  
7 two as provided in section five hundred eleven of this article,  
8 provided, however, that New York city police/fire revised plan members,  
9 New York city uniformed correction/sanitation revised plan members and  
10 investigator revised plan members shall not be eligible to retire for  
11 service prior to the attainment of twenty years of credited service, and  
12 provided further that for members of the New York city police pension  
13 fund, the early service retirement benefit shall not be reduced by the  
14 primary social security retirement benefit commencing at age sixty-two  
15 as provided in section five hundred eleven of this article.

16 c. A police/fire member, a New York city uniformed  
17 correction/sanitation revised plan member or an investigator revised  
18 plan member who retires with twenty-two years of credited service or  
19 less may become eligible for annual escalation of the service retirement  
20 benefit if [~~he~~] such member elects to have the payment of [~~his~~] such  
21 member's benefit commence on the date [~~he~~] such member would have  
22 completed twenty-two years and one month or more of service. In such  
23 event, the service retirement benefit shall equal two percent of final  
24 average salary for each year of credited service, less fifty percent of  
25 the primary social security retirement benefit commencing at age sixty-  
26 two as provided in section five hundred eleven of this article, except  
27 that for members of the New York city police pension fund, the service  
28 retirement benefit shall not be reduced by the primary social security  
29 retirement benefit commencing at age sixty-two as provided in section  
30 five hundred eleven of this article.

31 d. Notwithstanding anything to the contrary in any other law,  
32 police/fire members of the New York city police pension fund shall be  
33 eligible for a normal service retirement benefit in lieu of an early  
34 service retirement benefit upon completing twenty years of service  
35 pursuant to subdivision d of section five hundred three of this article.

36 § 2. Section 511 of the retirement and social security law is amended  
37 by adding a new subdivision h to read as follows:

38 h. This section shall not apply to members of the New York city police  
39 pension fund who receive a service retirement benefit pursuant to  
40 section five hundred five of this article or a deferred vested benefit  
41 pursuant to section five hundred sixteen of this article.

42 § 3. Subdivision c of section 516 of the retirement and social securi-  
43 ty law, as amended by chapter 18 of the laws of 2012, is amended to read  
44 as follows:

45 c. The deferred vested benefit of police/fire members, New York city  
46 police/fire revised plan members, New York city uniformed  
47 correction/sanitation revised plan members or investigator revised plan  
48 members shall be a pension commencing at early retirement age equal to  
49 two and one-tenths percent of final average salary times years of cred-  
50 ited service, less fifty percent of the primary social security retire-  
51 ment benefit commencing at age sixty-two, as provided in section five  
52 hundred eleven of this article, except that for members of the New York  
53 city police pension fund, the deferred vested benefit shall not be  
54 reduced by the primary social security retirement benefit commencing at  
55 age sixty-two as provided in section five hundred eleven of this  
56 article. A police/fire member, a New York city police/fire revised plan

1 member, a New York city uniformed correction/sanitation revised plan  
 2 member or investigator revised plan member may elect to receive [~~his~~]  
 3 such member's vested benefit commencing at early retirement age or age  
 4 fifty-five. If the vested benefit commences before early retirement age,  
 5 the benefit shall be reduced by one-fifteenth for each year, if any,  
 6 that the member's early retirement age is in excess of age sixty, and by  
 7 one-thirtieth for each additional year by which the vested benefit  
 8 commences prior to early retirement age. If such vested benefit is  
 9 deferred until after such member's normal retirement age, the benefit  
 10 shall be computed and subject to annual escalation in the same manner as  
 11 provided for an early retirement benefit pursuant to subdivision c of  
 12 section five hundred five of this article.

13 § 4. Notwithstanding any provision of law, rule or regulation to the  
 14 contrary, any effect on a participating employer's contribution rate due  
 15 to the provisions of this act shall not apply to the calculation of such  
 16 participating employer's contribution rate for the purposes of subdivi-  
 17 sion c of section 500 of the retirement and social security law.

18 § 5. This act shall take effect on the sixtieth day after it shall  
 19 have become a law.

FISCAL NOTE.--Pursuant to Legislative Law, Section 50:

SUMMARY: This proposed legislation would eliminate the offset equal to  
 50% of the primary social security benefit in the service, early  
 service, and vested retirement benefits for Tier 3 members of the New  
 York City Police Pension Fund (POLICE).

Projected contributions include future new hires that may be impacted.  
 For Fiscal Year 2051 and beyond, the expected increase in normal cost as  
 a level percent of pay for impacted new entrants is approximately 1.76%.

The entire increase in employer contributions will be allocated to New York City.

PRESENT VALUE OF BENEFITS: The Present Value of Benefits is the discounted expected value of benefits paid to current members if all assumptions are met, including future service accrual and pay increases. Future new hires are not included in this present value.

UNFUNDED ACCRUED LIABILITY (UAL): Actuarial Accrued Liabilities are the portion of the Present Value of Benefits allocated to past service. Changes in UAL for active members were amortized over the expected remaining working lifetime of those impacted using level dollar payments. UAL attributable to inactive members was recognized in the first year.

CENSUS DATA: The estimates presented herein are based on preliminary census data collected as of June 30, 2024. The census data for the impacted population is summarized below.

IMPACT ON MEMBER BENEFITS: Currently, Tier 3 normal service retirement, early service retirement, and vested retirement benefits are subject to an offset equal to 50% of the primary social security benefit as defined in Retirement and Social Security Law (RSSL) Section 511 beginning at age 62.

Under the proposed legislation, the offset for such benefits would be eliminated for POLICE members, resulting in an increase in benefits

ASSUMPTIONS AND METHODS: The estimates presented herein have been calculated based on the Revised 2021 Actuarial Assumptions and Methods of the impacted retirement systems. In addition:

\* New entrants were assumed to replace exiting members so that total payroll increases by 3% each year for impacted groups. New entrant demographics were developed based on data for recent new hires and actuarial judgement.

RISK AND UNCERTAINTY: The costs presented in this Fiscal Note depend highly on the actuarial assumptions, methods, and models used, demographics of the impacted population, and other factors such as investment, contribution, and other risks. If actual experience deviates from actuarial assumptions, the actual costs could differ from those presented herein. Quantifying these risks is beyond the scope of this Fiscal Note.

This Fiscal Note is intended to measure pension-related impacts and does not include other potential costs (e.g., administrative and Other Postemployment Benefits). This Fiscal Note does not reflect any chapter laws that may have been enacted during the current legislative session.

This Fiscal Note does not include cost analyses relating to provisions contained in RSSL Section 500(c).

STATEMENT OF ACTUARIAL OPINION: Marek Tyszkiewicz and Gregory Zelikovsky are members of the Society of Actuaries and the American Academy of Actuaries. We are members of NYCERS, but do not believe it impairs our objectivity, and we meet the Qualification Standards of the American Academy of Actuaries to render the actuarial opinion contained herein. To the best of our knowledge, the results contained herein have been prepared in accordance with generally accepted actuarial principles and procedures and with the Actuarial Standards of Practice issued by the Actuarial Standards Board.
