AN ACT to permit accidental death benefits and/or special accidental death benefits to be awarded to the beneficiary of Patricia Espinosa

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Notwithstanding the provisions of any law, rule or regulation to the contrary, Patricia Espinosa, who was a member of the New
2 York state and local police and fire retirement system employed as a
3 police officer by the county of Nassau, and who died on January 31, 2026
4 as the result of an accident which occurred while she was travelling to
5 work, shall be deemed to have died as the natural and proximate result
6 of an accident sustained in the performance of duty. The statutory beneficiary or beneficiaries of Patricia Espinosa shall be eligible to
7 receive the accidental death benefit and/or special accidental death
8 benefit if an application therefor is filed within one year of the
9 effective date of this act. Any amounts paid by the New York state and
10 local police and fire retirement system as the result of the death of
11 Patricia Espinosa prior to the receipt of the accidental death benefit
12 and/or special accidental death benefit pursuant to this section shall
13 be deducted from the benefit payable on an actuarially equivalent basis
14 over the expected future lifetime of the statutory beneficiary or beneficiaries.

16 § 2. All costs associated with this act shall be borne by the state of
17 New York.

18 § 3. This act shall take effect immediately and shall be deemed to
19 have been in full force and effect on and after January 31, 2026.

20 FISCAL NOTE.--Pursuant to Legislative Law, Section 50:

21 This bill would make the statutory beneficiaries of deceased police officer Patricia Espinosa eligible to receive an accidental death benefit.

fit pursuant to sections 361 and 361-a of the retirement and social security law (RSSL). The current death benefit will be recalculated, and payment will be made to the statutory beneficiaries retroactive to January 31, 2026, the date of Patricia Espinosa's death.

There will be an immediate past service cost of \$3.20 million borne by the state of New York as a one-time payment. This cost assumes that payment will be made on March 1, 2027.

This bill will not increase the state of New York's annual contributions.

Summary of relevant resources:

Membership data as of March 31, 2025 was used to measure the impact of the bill, the same data used in the Actuarial Valuations dated April 1, 2025. Distributions and other statistics can be found in the 2025 Report of the Actuary and the 2025 Annual Comprehensive Financial Report.
