2 (Whereupon, at 3:00 p.m., the
3 Acting President gaveled the session to order,
4 discussions were held off the record, and the
5 Senate stood at ease at 3:19 p.m.)

6 (Whereupon, the Senate reconvened
7 at 4:21 p.m.)

8 ACTING PRESIDENT STEWART-COUSINS:
9 Senator Smith.

10 SENATOR SMITH: Madam President,
11 have we received the proclamation from the
12 Governor's office? I'd like to have that
13 read.

14 ACTING PRESIDENT STEWART-COUSINS:
15 The Secretary will read.

16 THE SECRETARY: "Proclamation.

17 "Pursuant to the power vested in me
18 by Article IV, Section 3 of the Constitution,
19 I hereby convene the Senate in Extraordinary
20 Session at the Capitol, in the City of Albany,
21 on the twenty-third day of June, two thousand
22 nine, at three p.m., for the purpose of
23 considering legislation with respect to
24 various subjects.

1 "Given under my hand and the privy
2 seal of the State, in the City of Albany, this
3 twenty-second day of June in the year
4 two thousand nine, David A. Paterson,
5 Governor."

6 ACTING PRESIDENT STEWART-COUSINS:
7 The proclamation having been read, the Senate
8 returns to extraordinary session.

9 And the record should reflect a
10 quorum of all 62 Senators present in the
11 chamber when we began this extraordinary
12 session at 3:00 p.m. today.

13 Senator Smith.

14 SENATOR SMITH: Yes, thank you,
15 Madam President.

16 Madam President, I move that we
17 have an immediate meeting of the Rules
18 Committee in the Majority Conference Room, and
19 that we stand at ease until such time as we
20 return.

1 The Senate will stand at ease

6 at 4:32 p.m.)

7 ACTING PRESIDENT STEWART-COUSINS:
8 The Senate will come to order.

9 Majority Leader Smith.

10 SENATOR SMITH: Yes, Madam
