21 Kevin Patrick Dobson, Sr. He is remembered as a
22 loving father and dedicated officer whose
23 commitment to public safety always remained
24 unwavering.

25 Trooper Dobson gave his life in

1 service to the State of New York. He was struck
2 and killed by a vehicle on the I-290, near the
3 Colvin Boulevard exit, during a traffic stop in
4 March of 2011.

5 His life was taken in the line of
6 duty while he was working to keep our roads
7 safe. Now it's up to us to ensure the memory of
8 Trooper Dobson, and the sacrifices he made, live
9 on for generations to come.

10 This legislation will designate the
11 Interstate 290 bridge that crosses State Route
12 425 as the New York State Trooper Kevin P. Dobson
13 Sr. Memorial Bridge. It will serve as a reminder
14 for all Western New Yorkers that our highways
15 were made safe by Trooper Dobson and his brothers
16 and sisters in uniform.

17 It will memorialize the life of
18 Trooper Dobson and help demonstrate our steadfast
19 gratitude for the selfless actions of the
20 hardworking men and women who serve in the
21 State Police force and local police agencies.

22 In the days and months since his
23 life was tragically taken in the line of duty,
24 our community has sought ways to commemorate
25 Trooper Dobson's service and sacrifice. The

1 Trooper Kevin Dobson Memorial Bridge will
2 complement the State Police efforts to
3 commemorate his life with a new monument at the
4 Clarence Barracks, where he nobly served.

5 Trooper Kevin Dobson was forever
6 committed to his duty to protect and serve our
7 community. He went above and beyond, always
8 working hard to keep our roads and neighborhoods
9 safe.

10 Today our thoughts and prayers go
11 out to Trooper Dobson's family and friends, and
12 we thank all those who have dedicated their lives
13 to law enforcement. Trooper Dobson made the
14 ultimate sacrifice, and the memory of that
15 sacrifice and his over 13 years of service to
16 this state will live on for years to come, as
17 motorists every day cross the soon-to-be-named
18 Trooper Kevin P. Dobson Sr. Memorial Bridge.

19 I had the opportunity to speak to
20 Dick Dobson, the father of Trooper Dobson, a few
21 weeks back when we introduced this legislation,
22 and again today when I saw it was coming to the
23 floor for this vote. The level of gratitude and
24 appreciation felt by his family for this gesture
25 is immeasurable, and I was asked to pass on this

1 sentiment to this honorable body.

2 Trooper Dobson left behind children
3 Kevin Patrick Jr., Jamie Kathleen, and Brooke
4 Lauren Dobson, as well as stepson Andrew Hastings
5 and life partner Bridgett Hastings.

6 I want to thank my colleagues for
7 supporting this legislation, and I want to
8 specifically thank the Western New York
9 delegation as well as the chair of the
10 Transportation Committee, Senator Fuschillo, for
11 helping to bring this to a floor vote.

12 This was a collective Western
13 New York effort to move this bill through the
14 Senate, and I'm hopeful the Assembly will move
15 quickly to pass this legislation and to move it
16 to the Governor's desk for his signature.

24 ACTING PRESIDENT VALESKY:

1 (Applause.)

2 ACTING PRESIDENT VALESKY: The
3 Secretary will read.

7 ACTING PRESIDENT VALESKY: Read the

14 THE SECRETARY: Ayes, 62.

15 ACTING PRESIDENT VALESKY: The bill

20 ACTING PRESIDENT VALESKY: Read the
21 last section.

22 THE SECRETARY: Section 2. This

24 ACTING PRESIDENT VALESKY: Call the
25 roll.

1 (The Secretary called the roll.)

2 THE SECRETARY: Ayes, 62.

3 ACTING PRESIDENT VALESKY: The bill
4 is passed.

5 Senator Libous, that completes the
6 noncontroversial reading of Senate Supplemental
7 Calendar 53A.

8 SENATOR LIBOUS: Mr. President, can
9 we go back to the active list for the day. And
10 there's a controversial bill, Number 799. If we
11 could take the controversial bill up at this
12 time.

13 ACTING PRESIDENT VALESKY: On the
14 active list, Calendar Number 799. The Secretary
15 will place that bill before the house after
16 ringing the bells.

17 The Secretary will read.

18 THE SECRETARY: Calendar Number
19 799, by Member of the Assembly Morelle, Assembly
20 Print 6963B, an act to amend the Education Law.

21 SENATOR TKACZYK: Explanation.

22 ACTING PRESIDENT VALESKY: Senator
23 Fuschillo, an explanation has been requested by
24 Senator Tkaczyk.

25 SENATOR FUSCHILLO: Thank you very

1 much, Mr. President.

2 In 2011 the Legislature unanimously
3 passed a new law that for the first time would
4 allow for the insurance coverage for the
5 diagnosis, treatment and therapy for autism. And
6 we all applauded that law, and Governor Cuomo
7 signed it into law. And there was a big
8 celebration because it was the first time in
9 New York State that that would be made possible.

10 And I wish I could stand here and
11 say we were the first in the nation, but we
12 weren't. We followed other states. We were a
13 little behind.

14 Part of that legislation, part of
15 that law never required the licensing of applied
16 behavioral analysts. Two days before the law
17 went into effect -- and Senator Breslin, let me
18 thank you for your support as well, because I
19 know you were one of the coprimers on that bill.

20 It took effect November 1st of
21 2012. Two days before it was going to take
22 effect, the New York State Division of Financial
23 Services, the State Education Department and the
24 Department of Health changed the intent. And
25 what they did is they created a license for those

1 who perform the services.

2 Well, New York State doesn't have a
3 license. Only doctors or psychologists were
4 licensed under New York State to provide these
5 services. So those who didn't have this license
6 that New York State created and changed the
7 intent of the law were not allowed to apply for
8 insurance reimbursement.

9 So the numbers of those who could
10 apply went from about 700 individuals that were
11 applying these services that could now be
12 eligible for insurance reimbursement down to
13 about 70.

14 ACTING PRESIDENT VALESKY: Senator
15 Marcellino, why do you rise?

16 SENATOR MARCELLINO: I apologize
17 for rising, but I'm having difficulty hearing my
18 colleague because of the background noise. If we
19 could get some order.

20 ACTING PRESIDENT VALESKY: If we
21 could keep the noise down so that we could all
22 hear Senator Fuschillo's explanation of his bill.

23 SENATOR FUSCHILLO: Thank you very
24 much. Thank you, Senator Marcellino and
25 Mr. President.

1 What the legislation does is it
2 creates a license in two categories. And it
3 really undoes what the state had done when they
4 changed the intent of the law. And for the first
5 time, once this takes effect -- and the Assembly
6 just passed it unanimously today -- we will go
7 back to the original intent back in 2012.

8 SENATOR TKACZYK: If the sponsor
9 would yield for a question, please.

10 ACTING PRESIDENT VALESKY: Senator
11 Fuschillo, will you yield?

12 SENATOR FUSCHILLO: Yes, I will.

13 And, Senator, thank you for your
14 support. You and I talked briefly.

15 ACTING PRESIDENT VALESKY: The
16 sponsor yields.

17 SENATOR TKACZYK: Yes, thank you
18 for your explanation. I appreciate the bill and
19 the work that it took to get it here. I just had
20 two clarifying questions.

21 Under the bill, a new scope of
22 practice is going to be created. But this scope
23 of practice is only related to the treatment
24 professionals, not the direct care workers. Is
25 that correct?

1 SENATOR FUSCHILLO: That's correct.

2 SENATOR TKACZYK: And also, can you
3 just explain how 853 schools and special
4 education programs are impacted by this
5 legislation?

6 SENATOR FUSCHILLO: They're not
7 impacted by it. What the section does is it
8 organizes them, under Chapter 853 under the
9 Education Law, so they're considered charter
10 schools. And those are the private schools that
11 we see all over New York State providing the
12 services right now.

13 SENATOR TKACZYK: Thank you,
14 Senator Fuschillo.

15 On the bill, please.

16 ACTING PRESIDENT VALESKY: Senator
17 Tkaczyk on the bill.

18 SENATOR TKACZYK: I think this is a
19 great bill. I'm really happy to see it get to
20 the floor.

21 According to the Centers for Disease
22 Control, one in 88 children are diagnosed with an
23 autism spectrum disorder. When we provide the
24 ability for parents to get help from licensed
25 behavior analysts, I think that's a very good

1 thing. We're going to provide access to
2 qualified providers and ensure good consumer
3 protection for those families seeking that
4 assistance.

5 I want to applaud the Senator, and I
6 want to urge my colleagues to vote yes on this
7 bill.

8 Thank you.

9 ACTING PRESIDENT VALESKY: Thank
10 you, Senator Tkaczyk.

11 Seeing no other Senator who wishes
12 to be heard, the debate is closed. The Secretary
13 will ring the bell.

14 Read the last section.

15 THE SECRETARY: Section 16. This
16 act shall take effect July 1, 2014.

17 ACTING PRESIDENT VALESKY: Call the
18 roll.

19 (The Secretary called the roll.)

20 THE SECRETARY: Absent from
21 voting: Senators Parker and Squadron.

22 Ayes, 61.

23 ACTING PRESIDENT VALESKY: The bill
24 is passed.

25 Senator Libous, that completes the

1 controversial reading of today's calendar.

2 SENATOR LIBOUS: Mr. President, I'm
3 going to tell everybody what we're going to do
4 now.

5 We're going to call an immediate
6 meeting of the Finance Committee. We're going to
7 ask the Finance Committee to go to Room 332
8 immediately. And the sooner they get there,
9 there's a small agenda that they'll finish up
10 pretty quickly, and then we'll come back and we
11 have some nominees that are in the gallery today
12 that we have to take care of.

13 And when that gets done, I'll let
14 you know what the next step is.

15 ACTING PRESIDENT VALESKY: There is
16 an immediate meeting of the Senate Finance
17 Committee in Room 332 of the Capitol.

18 The Senate will stand at ease
19 pending the return of the Finance Committee.

20 SENATOR LIBOUS: Mr. President,
21 people can go to the Finance Committee, but I'd
22 like to return to motions before we stand at
23 ease.

24 ACTING PRESIDENT VALESKY: Motions
25 and resolutions.

1 SENATOR LIBOUS: On behalf of
2 Senator Zeldin, on page 22 I offer the following
3 amendments to Calendar Number 622, Senate Print
4 5037A, and ask that said bill retain its place on
5 the Third Reading Calendar.

6 ACTING PRESIDENT VALESKY: The
7 amendments are received, and the bill will retain
8 its place on the Third Reading Calendar.

9 SENATOR LIBOUS: Mr. President, at
10 this time I would ask that the Senate stand at
11 ease.

12 ACTING PRESIDENT VALESKY: The
13 Senate will now stand at ease.

14 (Whereupon, the Senate stood at ease
15 at 5:30 p.m.)

16 (Whereupon, the Senate reconvened at
17 5:48 p.m.)

18 SENATOR LIBOUS: Mr. President.

19 ACTING PRESIDENT VALESKY: Senator
20 Libous.

21 SENATOR LIBOUS: If we can go back
22 to reports of standing committees, I believe
23 there's a report of the Finance Committee at the
24 desk. I ask that it be read at this time.

25 ACTING PRESIDENT VALESKY: There is

1 a report of the Finance Committee at the desk.

2 The Secretary will read.

3 THE SECRETARY: Senator
4 DeFrancisco, from the Committee on Finance,
5 offers the following nominations.

6 As member and chairman of the State
7 Commission on Corrections, Thomas A. Beilein, of
8 Appleton.

9 ACTING PRESIDENT VALESKY: Senator
10 DeFrancisco.

11 SENATOR DeFRANCISCO: Yes. Are we
12 on the first nomination?

13 ACTING PRESIDENT VALESKY: We are.

14 SENATOR DeFRANCISCO: Okay. I move
15 the nomination of Thomas A. Beilein to continue
16 as chairman of the Commission on Correction.

17 He's been there approximately five
18 years. He is an outstanding citizen of this
19 state. He's done a wonderful job. His
20 background is outstanding. And he unanimously
21 passed through the Committee on Crime and
22 Corrections as well as the Finance Committee, and
23 I proudly move his nomination.

24 ACTING PRESIDENT VALESKY: Thank
25 you, Senator DeFrancisco.

1 Senator Gallivan on the nomination.

2 SENATOR GALLIVAN: Thank you,
3 Mr. President. I too rise to support the
4 nomination of Thomas A. Beilein to be reappointed
5 as chair of the Commission of Corrections.

6 I've worked with the chairman in my
7 capacity as sheriff of Erie County when he was
8 the sheriff of Niagara County. He's an honorable
9 man. I concur without repeating what Senator
10 DeFrancisco has said about his qualifications.

11 He's been in the position and we've
12 talked about the challenges facing the
13 commission, and they're very real. And I look
14 forward to working with him in the next several
15 years in that capacity.

16 Thank you, Mr. President.

17 ACTING PRESIDENT VALESKY: Thank
18 you, Senator Gallivan.

19 Senator Maziarz on the nomination.

20 SENATOR MAZIARZ: Thank you very
21 much, Mr. President.

22 I also rise to second this
23 nomination of Tom Beilein from Niagara County,
24 our former sheriff. Sheriff Beilein and I served
25 together in the county together when I was the

1 county clerk and he was the sheriff. I've known
2 the sheriff for well over 20 years now.

3 He's done an excellent job as the
4 chairman of the Commission of Corrections. This
5 is a great reappointment by Governor Cuomo.

6 And during the confirmation process
7 in both the Finance Committee and in the Crime
8 and Corrections Committee, Chairman Beilein
9 outlined very well the role of the commission and
10 what they do and some of the accomplishments that
11 he has had.

12 I'm also extremely impressed that
13 Senator DeFrancisco rose to endorse this
14 nomination, given the fact that Tom Beilein's
15 brother John, the coach of the Michigan
16 Wolverines, beat Syracuse. It was probably the
17 one time that, you know, Syracuse was defeated,
18 and Senator DeFrancisco still supports the
19 opposition.

20 (Laughter.)

21 SENATOR MAZIARZ: Thank you very
22 much, Mr. President.

23 ACTING PRESIDENT VALESKY: Thank
24 you, Senator Maziarz.

25 All those in favor Of reappointing

1 Thomas A. Beilein, of Appleton, as a member and
2 chairman of the State Commission on Correction
3 signify by saying aye.

4 (Response of "Aye.")

5 ACTING PRESIDENT VALESKY: Opposed,
6 nay.

7 (No response.)

8 ACTING PRESIDENT VALESKY: Thomas
9 A. Beilein is hereby confirmed as member and
10 chairman of the State Commission on Correction.

11 He joins us today in the gallery.

12 Congratulations. Thank you for your
13 service.

14 (Standing ovation.)

15 ACTING PRESIDENT VALESKY: The
16 Secretary will read.

17 THE SECRETARY: As member of the
18 State Commission on Correction, Thomas J.
19 Loughren, of McDonough.

20 ACTING PRESIDENT VALESKY: Senator
21 DeFrancisco.

22 SENATOR DeFRANCISCO: Yes, I'm
23 proud to also rise to move the nomination of
24 Thomas Loughren as a new commissioner of
25 corrections.

1 He went into great detail about his
2 background before the Crime and Corrections
3 Committee. If you haven't read his resume
4 thoroughly, you really should. He's got an
5 incredibly broad range of background that suits
6 him particularly for this particular position.

7 And as a result, I do move the
8 nomination and congratulate the Governor for this
9 fine appointment.

10 ACTING PRESIDENT VALESKY: Thank
11 you, Senator DeFrancisco.

12 Senator Libous on the nomination.

13 SENATOR LIBOUS: Thank you,
14 Mr. President.

15 I too want to rise on Tom Loughren,
16 because I had the pleasure of working with Tom
17 when he was the sheriff of Chenango County. And
18 he did a fabulous job there, he was extremely
19 well respected. The men and women who worked for
20 him, they liked him and they worked very hard.

21 He did a number of things when it
22 came to not only just stopping crime but dealing
23 with drugs and a whole host of things. And we
24 worked together with some programs.

25 And I just think that the Governor

1 has chosen as outstanding individual. I was very
2 pleased when I saw his name come up. And Senator
3 Gallivan asked me if I knew Tom, and I was very
4 pleased to tell him that I do know him, he did a
5 great job as a public servant as sheriff of
6 Chenango County, and he will serve us very well
7 on this committee.

8 So, Tom, I congratulate you, and I
9 congratulate the Governor for this fine nominee.

10 ACTING PRESIDENT VALESKY: Thank
11 you, Senator Libous.

12 Senator Gallivan on the nomination.

13 SENATOR GALLIVAN: Thank you,
14 Mr. President.

15 I rise again to support the
16 nomination of Thomas Loughren as a member of the
17 State Commission of Correction. Like Sheriff
18 Beilein, we worked together in our former lives,
19 and Tom Loughren comes tremendously qualified
20 with a tremendous background very well suited for
21 this position.

22 But I would just point out for all
23 my colleagues, in addition to what you have
24 heard, he served at one time as the president of
25 the State Sheriffs Association and a member of

1 the State Law Enforcement Accreditation Council.

2 And he's a true criminal justice
3 professional, well suited to meet the challenges
4 of the Commission of Correction. I'll be voting
5 in the affirmative.

6 ACTING PRESIDENT VALESKY: Thank
7 you, Senator Gallivan.

8 Senator Seward on the nomination.

9 SENATOR SEWARD: Thank you very
10 much, Mr. President.

11 I too rise in support of Tom
12 Loughren to become a member of the State
13 Commission of Correction. I share a portion of
14 Chenango County with Senator Libous and in that
15 capacity have had the opportunity to personally
16 observe the fine work of Tom as the sheriff of
17 Chenango County.

18 He did an outstanding job in that
19 role. He's operated a correctional facility. He
20 walks the walk and talks the talk as a lawman.
21 He has a wide breadth of experience in law
22 enforcement, a very practical background. And he
23 will serve the people of the State of New York
24 very, very well as member of the State Commission
25 of Corrections.

1 So I congratulate you, Tom, and I
2 congratulate the Governor on making an
3 outstanding nomination. I'm very pleased to rise
4 in support.

5 ACTING PRESIDENT VALESKY: Thank
6 you, Senator Seward.

7 Senator Farley on the nomination.

8 SENATOR FARLEY: Yes, I rise in
9 support of this nomination. You know, for
10 anybody in this chamber, if you look at this
11 man's resume and how fortunate we are to get
12 somebody to serve in a position with the
13 background that he has, particularly in law
14 enforcement, in homeland security and so many
15 things.

16 I also on a personal basis chatted
17 with him at good length in the waiting room
18 before he went in for confirmation, and he's a
19 person of integrity and somebody that truly we're
20 very fortunate to have serve as commissioner.

21 I rise and enthusiastically second
22 this nomination.

23 ACTING PRESIDENT VALESKY: Thank
24 you, Senator Farley.

25 The question is on the appointment

1 of Thomas J. Loughren, of McDonough, as a member
2 of the State Commission of Correction. All in
3 favor signify by saying aye.

4 (Response of "Aye.")

5 ACTING PRESIDENT VALESKY: Opposed,
6 nay.

7 (No response.)

9 J. Loughren is hereby confirmed as a member of
10 the State Commission of Correction.

11 He joins us today in the gallery.

13 (Standing ovation.)

18 Historic Preservation: Jay A. DiLorenzo, of
19 Schenectady, and Douglas A. Perrelli, Ph.D., of
20 Buffalo.

21 As members of the State Park,
22 Recreation and Historic Preservation Commission
23 for the City of New York: Alexander Durst, of
24 New York; Allison Whipple Rockefeller, of
25 New York; and Simon C. Roosevelt, of New York.

1 ACTING PRESIDENT VALESKY: All in
2 favor of the aforementioned nominations signify
3 by saying aye.

4 (Response of "Aye.")

5 ACTING PRESIDENT VALESKY: Opposed,
6 nay.

7 (No response.)

8 ACTING PRESIDENT VALESKY: The
9 nominees are confirmed.
10 Senator Libous.

11 SENATOR LIBOUS: Mr. President, I
12 believe Senator Carlucci has a motion. If we can
13 go back too motions and resolutions.
