2 ACTING PRESIDENT BAILEY: The
3 Senate will come to order.

4 I ask everyone present to please
5 rise and recite the Pledge of Allegiance.

6 (Whereupon, the assemblage recited
7 the Pledge of Allegiance to the Flag.)

8 ACTING PRESIDENT BAILEY: In the
9 absence of clergy, let us bow our heads in a
10 moment of silent reflection or prayer.

11 (Whereupon, the assemblage respected
12 a moment of silence.)

13 ACTING PRESIDENT BAILEY: Reading
14 of the Journal.

15 THE SECRETARY: In Senate,
16 Wednesday, April 15, 2026, the Senate met
17 pursuant to adjournment. The Journal of Tuesday,
18 April 14, 2026, was read and approved. On
19 motion, the Senate adjourned.

20 ACTING PRESIDENT BAILEY: Without
21 objection, the Journal stands approved as read.

22 Presentation of petitions.

25 Reports of standing committees.

1 Reports of select committees.

2 Communications and reports from
3 state officers.

4 Motions and resolutions.

5 Senator Gianaris.

6 SENATOR GIANARIS: Good morning,
7 Mr. President.

8 ACTING PRESIDENT BAILEY: Good
9 morning.

10 We will begin with an immediate
11 meeting of the Rules Committee in Room 332.

12 ACTING PRESIDENT BAILEY: There
13 will be an immediate meeting of the
14 Rules Committee in Room 332.

15 SENATOR GIANARIS: The Senate
16 stands at ease.

17 ACTING PRESIDENT BAILEY: The
18 Senate will stand at ease.

19 (Whereupon, the Senate stood at ease
20 at 11:30 a.m.)

21 (Whereupon, the Senate reconvened at
22 11:37 a.m.)

23 ACTING PRESIDENT MAYER: The Senate
24 will return to order.

25 Senator Gianaris.

1 SENATOR GIANARIS: Madam President,
2 there's a report of the Rules Committee at the
3 desk. Can we take that up, please.

4 ACTING PRESIDENT MAYER: The
5 Secretary will read.

6 THE SECRETARY: Senator
7 Stewart-Cousins, from the Committee on Rules,
8 reports the following bill:

9 Senate Print 9918, by
10 Senator Gianaris, an act making appropriations
11 for the support of government.

12 The bill reports direct to third
13 reading.

14 SENATOR GIANARIS: Move to accept
15 the report of the Rules Committee.

16 ACTING PRESIDENT MAYER: All those
17 in favor of accepting the report of the
18 Rules Committee please signify by saying aye.

19 (Response of "Aye.")

20 ACTING PRESIDENT MAYER: Opposed,
21 nay.

22 (No response.)

23 ACTING PRESIDENT MAYER: The report
24 of the Rules Committee is accepted.

25 Senator Gianaris.

1 SENATOR GIANARIS: Let's move to
2 the supplemental calendar, please.

3 ACTING PRESIDENT MAYER: The
4 Secretary will read.

5 There's a substitution at the desk.

6 The Secretary will read.

7 THE SECRETARY: Senator Gianaris
8 moves to discharge, from the Committee on Rules,
9 Assembly Bill Number 11000 and substitute it for
10 the identical Senate Bill 9918, Third Reading
11 Calendar 696.

12 ACTING PRESIDENT MAYER: The
13 substitution is so ordered.

14 The Secretary will read.

15 THE SECRETARY: Calendar Number
16 696, Assembly Bill Number 11000, by
17 Assemblymember Pretlow, an act making
18 appropriations for the support of government.

19 SENATOR GIANARIS: Is there a
20 message of necessity and appropriation at the
21 desk?

22 ACTING PRESIDENT MAYER: There is a
23 message of necessity and appropriation at the
24 desk.

25 SENATOR GIANARIS: Move to accept

1 the message.

2 ACTING PRESIDENT MAYER: All those
3 in favor of accepting the message please signify
4 by saying aye.

5 (Response of "Aye.")

6 ACTING PRESIDENT MAYER: Opposed,
7 nay.

8 (Response of "Nay.")

9 ACTING PRESIDENT MAYER: The
10 message is accepted, and the bill is before the
11 house.

12 SENATOR LANZA: Lay it aside.

13 ACTING PRESIDENT MAYER: The bill
14 is laid aside.

15 Senator Gianaris, that completes the
16 reading of the supplemental calendar.

17 SENATOR GIANARIS: Can we just
18 temporarily stand at ease while we await the
19 debate on the one bill.

20 ACTING PRESIDENT MAYER: The Senate
21 will stand at ease.

22 (Whereupon, the Senate stood at ease
23 at 11:38 a.m.)

24 (Whereupon, the Senate reconvened at
25 11:39 a.m.)

1 ACTING PRESIDENT MAYER: The Senate
2 will return to order.

3 The Secretary will ring the bell.

4 The Secretary will read.

5 SENATOR GIANARIS: We're on the
6 controversial calendar, I believe, right?

7 ACTING PRESIDENT MAYER: Yes.

8 SENATOR GIANARIS: Thank you.

9 THE SECRETARY: Calendar Number
10 696, Assembly Bill Number 11000, by
11 Assemblymember Pretlow, an act making
12 appropriations for the support of government.

13 ACTING PRESIDENT MAYER: Senator
14 O'Mara, why do you rise?

15 SENATOR O'MARA: Yes, thank you,
16 Madam President. I wonder if the sponsor would
17 yield for a few questions.

18 ACTING PRESIDENT MAYER: Senator
19 Gianaris, will you yield?

20 SENATOR GIANARIS: Yes.

21 ACTING PRESIDENT MAYER: The
22 Senator yields.

23 SENATOR O'MARA: Good morning,
24 Senator.

25 We're on our fourth extender on this

1 late budget at this point. And my understanding
2 is that this extender takes us through Monday,
3 and it's adding an additional \$79 million in
4 additional spending, bringing our total
5 extenders' amount of these four to \$7.2 billion.

6 Is that correct?

7 SENATOR GIANARIS: No, because the
8 extender takes us to Monday, not through Monday.
9 But otherwise, yes, you're correct.

10 SENATOR O'MARA: Okay.

11 Through you, Madam President, if the
12 Senator will continue to yield.

13 ACTING PRESIDENT MAYER: Do you
14 continue to yield?

15 SENATOR GIANARIS: Yes.

16 ACTING PRESIDENT MAYER: The
17 Senator will yield.

18 SENATOR O'MARA: So then with that
19 we will need to do -- if the nine budget bills
20 aren't done by Monday, and passed, we'll need to
21 do another extender in Monday.

22 SENATOR GIANARIS: I would expect
23 that to happen, Senator O'Mara.

24 SENATOR O'MARA: Through you,
25 Madam President, if the Senator will continue to

1 yield.

2 ACTING PRESIDENT MAYER: Do you
3 continue to yield?

4 SENATOR GIANARIS: Yes.

5 ACTING PRESIDENT MAYER: The
6 Senator yields.

7 SENATOR O'MARA: Can you explain to
8 us what is being covered with this \$79 million in
9 additional spending to get us to Monday?

10 SENATOR GIANARIS: Well, as you
11 pointed out, it's a very nominal amount in the
12 scheme of the over 7 billion we've appropriated
13 so far. So these are just routine additional
14 appropriations that the state needs to make
15 payments.

16 SENATOR O'MARA: Through you,
17 Madam President, if the Senator will continue to
18 yield.

19 ACTING PRESIDENT MAYER: Do you
20 continue to yield?

21 SENATOR GIANARIS: Yes.

22 ACTING PRESIDENT MAYER: The
23 Senator will yield.

24 SENATOR O'MARA: Well, \$79 million
25 may not be a huge percentage of the overall

1 budget that's going to be about 270 billion.
2 Seventy-nine million dollars still is not a
3 nominal amount, in my opinion, and I'm sure
4 neither in any opinion of any constituent that I
5 represent.

6 So can you give us some detail on
7 what the \$79 million is actually going to go to?

8 SENATOR GIANARIS: Sure.

9 I'll give you the whole list, since
10 you asked, and since you like longer answers,
11 from what I remember.

12 (Laughter.)

13 SENATOR GIANARIS: Twenty-five
14 thousand for personal service; \$23.5 million for
15 Social Security, 675,000 for the metropolitan
16 commuter transportation mobility tax, 350,000 for
17 SUNY pensions, 178,000 for auto accidents,
18 4.28 for the Department of Health Center for
19 Community Health. What else do we have here?
20 196,000 for the Community Support Program at the
21 Justice Center. Thirty million for unemployment
22 benefits -- I'm sure you want those to go out.
23 Thirteen-point-1 million for the MTA support;
24 3.9 million for OPWDD non-Medicaid residential
25 services; 960,000 for non-Medicaid day services;

1 1.08 million for non-Medicaid family support and
2 services; 624,000 for non-Medicaid employment
3 services; 24,000 for homeless veterans housing;
4 and 160,000 for other non-Medicaid payments.

5 SENATOR O'MARA: Thank you.

6 Through you, Madam President, if the
7 Senator will continue to yield.

8 ACTING PRESIDENT MAYER: Do you
9 continue to yield?

10 SENATOR GIANARIS: Yes.

11 ACTING PRESIDENT MAYER: The
12 Senator yields.

13 SENATOR O'MARA: Are there any
14 table targets yet for our various budget
15 conference committees?

16 SENATOR GIANARIS: No.

17 SENATOR O'MARA: Through you,
18 Madam President, if the Senator will continue to
19 yield.

20 ACTING PRESIDENT MAYER: Do you
21 continue to yield?

22 SENATOR GIANARIS: Yes.

23 ACTING PRESIDENT MAYER: The
24 Senator yields.

25 SENATOR O'MARA: Do you expect that

1 we will have table targets on Monday for --

2 SENATOR GIANARIS: No.

3 SENATOR O'MARA: -- the joint
4 conference committees to start to work?

5 SENATOR GIANARIS: No.

6 ACTING PRESIDENT MAYER: Through
7 you, Madam President, if the Senator will
8 continue to yield.

9 ACTING PRESIDENT MAYER: Do you
10 continue to yield?

11 SENATOR GIANARIS: Yes.

12 ACTING PRESIDENT MAYER: The
13 Senator yields.

14 SENATOR O'MARA: Can you outline
15 for us why not? What are the sticking points to
16 getting to table targets?

17 SENATOR GIANARIS: The sticking
18 points are the same they've been since we've been
19 having these conversations. We continue to
20 negotiate with the Executive over CLCPA
21 rollbacks, SEQRA reform, auto insurance issues,
22 immigration, aid to New York City, and various
23 others.

24 I will say this week has been
25 somewhat more promising, as discussions seem to

1 be making slow and steady progress.

2 SENATOR O'MARA: Through you,
3 Madam President, if the Senator will continue to
4 yield.

5 ACTING PRESIDENT MAYER: Do you
6 continue to yield?

7 SENATOR GIANARIS: Yes.

8 ACTING PRESIDENT MAYER: The
9 Senator yields.

10 SENATOR O'MARA: At least I've read
11 in the news in recent days there's been a new
12 proposal thrown out there on policy, and that's
13 the pied-a-terre tax on second homes in New York
14 City. That's something new that's been thrown
15 out. Is that thrown out by the Governor or is
16 that thrown out by Mayor Mamdani through the
17 Governor?

18 SENATOR GIANARIS: Senator O'Mara
19 has been here long enough to know that it was
20 originally a Senate Democrat proposal by then
21 Senator Hoylman-Sigal, now borough president of
22 Manhattan.

23 And so the idea has been in
24 existence for several years. It's something that
25 the Governor has thrown her support behind in the

1 last couple of days.

2 SENATOR O'MARA: Thank you,
3 Senator.

4 Madam President, if the Senator will
5 continue to yield.

6 ACTING PRESIDENT MAYER: Do you
7 continue to yield?

8 SENATOR GIANARIS: Yes.

9 ACTING PRESIDENT MAYER: The
10 Senator yields.

11 SENATOR O'MARA: With regards to
12 the CLCPA issues that are a stumbling point at
13 this point, can you describe for us what
14 proposals the Governor has put forth in regards
15 to extending some of these deadlines on the
16 CLCPA?

17 SENATOR GIANARIS: No.

18 SENATOR O'MARA: Through you,
19 Madam President, if the Senator will continue to
20 yield.

21 ACTING PRESIDENT MAYER: Do you
22 continue to yield?

23 SENATOR GIANARIS: Yes.

24 ACTING PRESIDENT MAYER: The
25 Senator yields.

1 SENATOR O'MARA: Has the Governor
2 put forth specific issues with regards to changes
3 to the CLCPA?

4 SENATOR GIANARIS: Yeah, there have
5 been conversations back and forth around elements
6 of the CLCPA.

7 SENATOR O'MARA: Through you,
8 Madam President, if the Senator will continue to
9 yield.

10 ACTING PRESIDENT MAYER: Do you
11 continue to yield?

12 SENATOR GIANARIS: Yes.

13 ACTING PRESIDENT MAYER: The
14 Senator yields.

15 SENATOR O'MARA: Another one of the
16 major stumbling blocks seems to be auto insurance
17 reform. Can you tell us where the proposals on
18 that stand in the discussions?

19 SENATOR GIANARIS: The Governor's
20 is what's publicly known through her proposals
21 and statements. And we are going back and forth
22 to try and find the right balance for what is in
23 the best interests of New Yorkers.

24 SENATOR O'MARA: Through you,
25 Madam President, if the Senator will continue to

1 yield.

2 ACTING PRESIDENT MAYER: Do you
3 continue to yield?

4 SENATOR GIANARIS: Yes.

5 ACTING PRESIDENT MAYER: The
6 Senator yields.

7 SENATOR O'MARA: And another major
8 issue is Tier 6 reform that could be
9 all-encompassing or it could be certain aspects
10 of it.

11 Where do those proposals stand up at
12 this point on reforms to Tier 6?

13 SENATOR GIANARIS: Well, I think
14 there's a genuine interest in making significant
15 reforms.

16 Senator O'Mara was also here, I
17 believe, when that was first enacted and the
18 then-members of our Democratic Conference walked
19 out in protest rather than supporting that.

20 So we recognize there's a need to
21 make changes, and we're trying to figure out
22 what's feasible while minimizing the burdens on
23 our local governments.

24 SENATOR O'MARA: Through you,
25 Madam President, if the Senator will continue to

1 yield.

2 ACTING PRESIDENT MAYER: Do you
3 continue to yield?

4 SENATOR GIANARIS: Yes.

5 ACTING PRESIDENT MAYER: The
6 Senator yields.

7 SENATOR O'MARA: Where do we stand
8 on the various SEQRA changes, proposals that are
9 out there on -- with regards to housing?

10 SENATOR GIANARIS: I think that's
11 something that all sides want to get to yes on.
12 And so I think, of all the issues we've talked
13 about, that may be the one that's furthest along
14 in terms of reaching agreement in line with what
15 the Governor is seeking.

16 SENATOR O'MARA: Through you,
17 Madam President, if the Senator will continue to
18 yield.

19 ACTING PRESIDENT MAYER: Do you
20 continue to yield?

21 SENATOR GIANARIS: Yes.

22 ACTING PRESIDENT MAYER: The
23 Senator yields.

24 SENATOR O'MARA: Can you give us a
25 general outline of where you think that is, where

1 everybody seems to be comfortable with?

2 SENATOR GIANARIS: No.

3 SENATOR O'MARA: Thank you.

4 Madam President, on the bill.

5 ACTING PRESIDENT MAYER: Senator
6 O'Mara on the bill.

7 SENATOR O'MARA: Not a lot of
8 helpful information for us, as usual on these
9 extenders, which is concerning.

10 And more importantly, no information
11 for the citizens of New York State on what is
12 really being discussed behind closed doors with
13 three people in a room on what will be somewhere
14 between a \$263 billion and \$270 billion budget.

15 As I've said before, New Yorkers
16 deserve to know what's being talked about behind
17 those closed doors and what progress is being
18 made so that they can actually weigh in to us and
19 tell us what they think about them, rather than
20 just coming out in the middle of the night --
21 which is par the course around here -- and voting
22 on them within a few hours.

23 We need the time to review these
24 things. The public needs the time to review
25 these things and provide us their input on those.

1 Where this extender takes us:
2 Three more days, gets us through Friday, Saturday
3 and Sunday into Monday. You know, I'll continue
4 to support this -- extenders at this point, but
5 it's growing increasingly concerning, the lack of
6 progress and, more importantly, the lack of
7 details on what is actually being discussed so
8 New Yorkers can know exactly what we're talking
9 about here behind closed doors in Albany.

10 Thank you.

11 ACTING PRESIDENT MAYER: Thank you,
12 Senator O'Mara.

13 Are there any other Senators wishing
14 to be heard?

15 Seeing and hearing none, debate is
16 closed.

17 Senator Gianaris.

18 SENATOR GIANARIS: Madam President,
19 we've agreed to restore this to the
20 noncontroversial supplemental calendar.

21 ACTING PRESIDENT MAYER: The bill
22 is restored to the noncontroversial supplemental
23 calendar.

24 Read the last section.

25 THE SECRETARY: Section 2. This

1 act shall take effect immediately.

2 ACTING PRESIDENT MAYER: Call the
3 roll.

4 (The Secretary called the roll.)

5 ACTING PRESIDENT MAYER: Senator
6 Weik to explain her vote.

7 SENATOR WEIK: Thank you,
8 Madam President.

9 It's April 16th. That's 15 days
10 past due, with no table targets, which is really
11 a terrible thing.

12 We have one-party rule in the State
13 of New York, and we can't seem to agree on enough
14 to get a budget on time, let alone 15 days late.

15 I'll be voting in the negative.

16 ACTING PRESIDENT MAYER: Senator
17 Weik to be recorded in the negative.

18 Announce the results.

19 THE SECRETARY: In relation to
20 Calendar 696, voting in the negative:
21 Senator Weik.

22 Ayes, 52. Nays, 1.

23 ACTING PRESIDENT MAYER: The bill
24 is passed.

25 Senator Gianaris, that completes the

1 reading of the supplemental calendar.

2 SENATOR GIANARIS: Let's now take
3 up the calendar.

4 ACTING PRESIDENT MAYER: The
5 Secretary will read.

1 Ayes, 52. Nays, 1.

2 ACTING PRESIDENT MAYER: The bill
3 is passed.

4 Senator Gianaris, that completes the
5 reading of the calendar.

6 SENATOR GIANARIS: Thank you,
7 Madam President.

8 Returning to motions for a moment,
9 on behalf of Senator Bailey, I wish to call up
10 Senate Print 5265, recalled from the Assembly,
11 which is now at the desk.

12 ACTING PRESIDENT MAYER: The
13 amendments are received, and the bill will retain

18 to amend the Correction Law.

19 SENATOR GIANARIS: Move to
20 reconsider the vote by which the bill was passed.

21 ACTING PRESIDENT MAYER: The
22 Secretary will call the roll on reconsideration.

24 THE SECRETARY: Ayes, 53.

25 ACTING PRESIDENT MAYER: The bill
